MP Steps to Event Notification

1. Receive Event Notification communication by email and phone
2. Log into DRIS
3. Respond with expected curtailment values
4. Be alert to receiving additional communications
 - *Extension of existing Event*
 - *Early Termination of existing Event*
 - *Notification for additional zones being called*
5. View Event Notifications and responses

Receive Event Notifications

SCR Event Notifications

- ◆ Market Participants will receive email and phone communications for SCR Event Notifications
 - *Provided that the MP has an SCR resource enrolled in at least one zone or subload pocket included on the SCR Event Notification with auction sales **greater** than zero in the month of the event*

EDRP Event Notifications

- ◆ Market Participants will receive email and phone communications for EDRP Event Notifications
 - *Provided that the MP has an EDRP resource enrolled in at least one zone or subload pocket on the EDRP Event Notification with a Declared Value greater than zero in the month of the event*
 - *Provided that the MP has an SCR resource enrolled in at least one zone or subload pocket on the EDRP Event Notification but the SCR resource has not sold capacity for the month of the event*

SCR Test Event Notifications

- ◆ Market Participants will receive email and phone communications for SCR Performance Tests
 - First Performance Test: For any SCR resource that is Enrolled at any time in the Capability Period on or before the date that is four business days prior to the date of the first test in the Capability Period (excluding the date of the test)
 - Second Performance Test: For any SCR resource that has an Enrolled status in the remainder of the Capability Period and was not eligible for the first performance test

Requirements to Receive Event Notification Communications

- ◆ Contacts in DRIS must be given the “Event Responder” contact assignment
 - *At least one Event Responder must have the **DRIS Web UI MP User privilege** to respond with expected curtailment values to an Event Notification*

- ◆ All MP organizations should maintain an “Event Responder” contact for **both the SCR and EDRP programs** regardless of whether the MP has enrolled resources in both programs
 - *Resources in the SCR program with no auction sales during the month of an Event will be notified to perform as an EDRP resource*

Event Notification Communication

- ◆ Email and phone notification will contain:
 - *Notification Type*
 - NYISO, TDRP, Performance Test 1, Performance Test 2
 - *Program*
 - *Message Type*
 - Day-Ahead Advisory, In-Day Advisory, 2-Hour Activation, Immediate Activation, Extension, Early Termination, Communication Test
 - *Zones*
 - *Start Time of Event*
 - *End Time of Event*
 - *Date of Tests (for Performance Test notifications)*

Event Notification Communication

- ◆ The email will not contain a link to DRIS
 - *The NYISO recommends each DRIS Web UI MP User create a bookmark to the DRIS site within browser Favorites or on the Desktop*
 - *Digital Certificates may be requested by MPs for more than one computer including for Windows-based work, laptop, and home computers*
 - *Digital Certificates may also be exported from one computer to another*
 - Described in section 4.4.1 of the MPUG, “2. Export for Use on Another Computer”

Special Case Resources that fail to participate in this event at the value of the KWs sold during 05/2012 will be subject to future de-rating, as described in the applicable ISO Procedures and the corresponding RIPs may be subject to deficiency penalties pursuant to ISO Procedures.

Phone Notification Steps

- ◆ The automated phone message will begin with
 - *“This is a message from the New York ISO”*

 - *Press 1 to Confirm receipt of the message*


Respond to Event Notifications

Respond to an Event Notification

- ◆ MPs are expected to respond with expected curtailment values to the following types of Events and Tests:
 - NYISO Events: Day-Ahead Advisory, In-Day Advisory, Activation 2 Hour, Immediate Activation
 - TDRP Events: Day-Ahead Advisory, In-Day Advisory, Activation 2 Hour, Immediate Activation
 - Performance Tests: Day-Ahead Advisory, Activation 2 Hour
- ◆ MPs are not expected to respond to Extension or Early Termination messages
- ◆ MPs are expected to respond with an acknowledgement of receipt to a Communication Test



- ◆ **Capability Period:** Capability Period of the Event Notification
- ◆ **Notification Type:** Type of Event Notification
 - *NYISO, TDRP, Performance Test 1, Performance Test 2*
- ◆ **Notice Date/Time:** Date and time when the Event Notification was created and distributed
- ◆ **Message Type:** Type of Event Notification Message
 - *Day-Ahead Advisory, In-Day Advisory, 2-Hour Activation, Immediate Activation, Extension, Early Termination, Communication Test*
- ◆ **Program:** Program associated with the Event Notification
 - *SCR or EDRP*

Notification Response Summary Data

- ◆ **Event Start Date/Time:** Date and time the Event begins
- ◆ **Event End Date/Time:** Date and time the Event ends
- ◆ **Zones:** Zone(s) or Subload Pocket(s) associated with the Event Notification
- ◆ **Response Expiration Date/Time:** Date and time past which expected curtailment responses to the Event Notification will no longer be accepted
- ◆ **Notification Created By:** Displayed as NYISO

Response Expiration Date/Time

- ◆ The Response Expiration Date/Time of an Event Notification is based on the Notice Date/Time
- ◆ All responses for expected curtailment values must be provided within 1 hour of the Notice Date/Time

Response Expiration Date/Time

- ◆ Once the Response Expiration Date/Time has passed, MPs will not be able to enter an expected curtailment value for the Event Notification
- ◆ MPs and their resources are expected to reduce load during the hours of the Event even if the MP has not entered the expected curtailment values before the Response Expiration Date/Time


Extension and Early Termination Notifications

- ◆ Message Types of Extension and Early Termination do not require a response and will not appear on the ***Notification Responses*** screen





Respond to an Event Notification

- ◆ MPs may update expected curtailment values to an Event Notification multiple times prior to the Response Expiration Date/Time
 - *The zonal response expected curtailment value with the most recent submittal date will be saved in DRIS*
 - *The Response User entering the response with the most recent submittal date will be saved with the Event Notification*

- ◆ The Expected kW Commitment may be greater than the Total kW Available
 - *DRIS will provide a Warning Message when the Expected kW Commitment exceeds 110% of the Total kW Available*
 - *Accept the Warning Message and the value will be saved*

Respond to an Event Notification

- ◆ To save the Expected kW Commitment value greater than 110% of the Total kW Available, click “OK” to the Warning Message and the value will be saved
