Communication Test Notification

- Communication Test Notifications will be used to test the Event Notification process
 - Verify that MP organizations are able to receive communications from the NYISO through email and phone
 - Verify that MP organizations have the ability to log into DRIS and respond to a notification
- Conducted periodically for all MPs enrolled in the SCR and/or EDRP programs
- Conducted for MPs new to the SCR and/or EDRP programs



Communication Test Notification

- Following the June deployment of DRIS, the NYISO will conduct a Communication Test of the Event Notification functionality
 - Communication Test requires action to be taken in DRIS by each MP organization
 - Tentatively scheduled for Wednesday, June 20, 2012



MP Steps to Communication Test

- Receive Communication Test Notification by email and phone
- 2. Log into DRIS
- Acknowledge receipt of Communication Test Notification
 - When multiple contacts at an MP organization receive the Communication Test Notification, only one user acknowledgement per MP organization is required in DRIS

- Email Subject Line:
 - NYISO Communication Test
- Email Content.

This is a communications test of the Demand Response Emergency Notification System for Emergency Demand Response Program (EDRP) resources and Special Case Resources in Zones A through K. This communication test is used to verify that Event Responder contacts in the Demand Response Information System (DRIS) are receiving e-mail and phone messages.

Individual resources are not required to respond.

Please have one representative from your organization provide a response within one hour by logging into the NYISO Demand Response Information System.

Phone Event Notification Steps

- The automated phone message will begin with
 - "This is a message from the New York ISO"
- Press 1 to play the message
- After listening to the message
 - Press 1 to Confirm receipt of the message
 - Press 2 to Replay the message





- Phone Introduction:
 - "This is a message from the New York ISO"
- Phone Message Content:

This is a <u>communications test</u> of the Demand Response Emergency Notification System for Emergency Demand Response Program resources and Special Case Resources in Zones A through K. This communication test is used to verify that all Event Responder contacts in the Demand Response Information System are receiving e-mail and phone messages. Individual resources are not required to respond. Please have one representative from your organization respond within one hour in accordance with separate email instructions. 


From the DRIS menu select Notification and then Respond






- The Notification Responses screen is displayed with the following defaulted search criteria
 - Events From Date equal to the system date
 - Event Notifications which have not expired






- From the Notification Requiring a Response Summary section of the screen, highlight the Communication Test notification and select "Respond"
- Communication Test Notifications have a Response Expiration Date/Time






Accept Confirmation Message by clicking "OK"






View Response to a Communication Test Notification

 DRIS returns to the Notification Responses screen with the Communication Test acknowledgement details viewable






View Response to a Communication Test Notification




- Communication
