MP Event Notification Contacts

- ◆ Review and update Event Notification contact information and assignments in DRIS
 - *The DRIS **Event Responder** contact assignment is required to receive Event Notifications for events, performance tests, and communication tests*
 - *All Event Responder contacts must have valid phone and email information in DRIS*
 - Phone extensions should be entered into DRIS with any applicable '#' or '*' preceding or following the numerical digits as prompted by the MP organization's phone system
 - Example: If the phone system prompts the caller to press a star and then enter the extension, the Extension Field in DRIS should be entered with the special character as: ***3333**

MP Event Notification Contacts

- ◆ All MP organizations must maintain at least one “Event Responder” contact as a **DRIS Web UI MP User** for **both the SCR and EDRP programs** regardless of whether or not the MP has enrolled resources in both programs
 - *In months when an SCR resource has no auction sales, it is treated as an EDRP resource and therefore, not obligated to perform in any SCR activated events*
 - *MPs **will not receive an SCR** Event Notification for SCR resources with no auction sales*
 - *MPs **will receive an EDRP** Event Notification for SCR resource with no auction sales, provided an EDRP event has been activated*

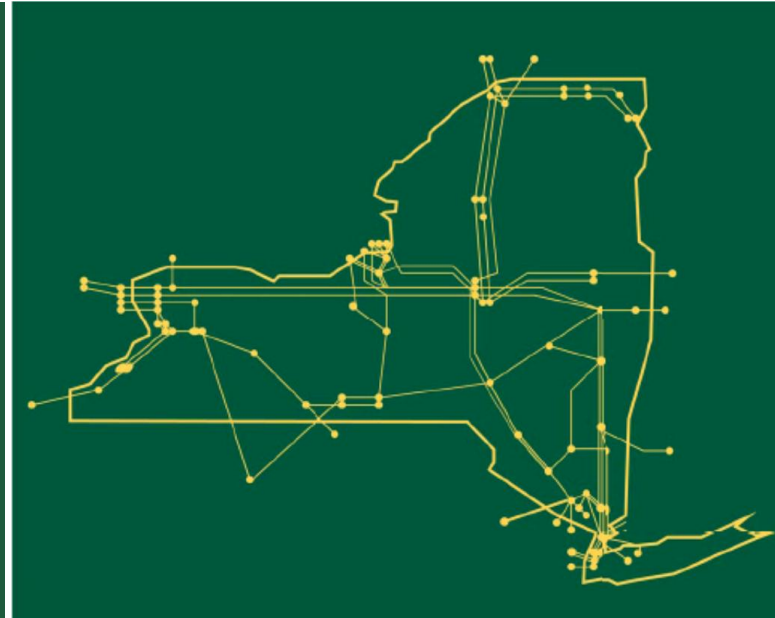
MP Event Notification Contacts

- ◆ MP contacts may be updated at any time in DRIS
- ◆ Only the contact information as it appears in DRIS at the date and time when the Event Notification is distributed will be used to notify Event Responder contacts
