Introduction

Document Intent

This document is intended to help NYISO Decision Support System (DSS) users determine data availability, given DSS's phased delivery approach.

Overview

The DSS makes Customer Settlements data available as it is created in the NYISO Billing and Accounting System (BAS) according to the DSS implementation scope at the time of data creation. Therefore as settlement days are either initially settled or are re-settled for prior periods in the BAS, the DSS will capture the associated data using the data scope implemented at the time the data is created.

DSS presents data for all time periods of NYISO settlements (11/1999 - to-date), but only if it is created after the noted DSS release dates. Therefore, as months are settled or re-settled, the DSS will make the associated data available. However, data created prior to these release dates will not be available.

For example: If 01/21/2000 was initially settled on 01/23/2000, and re-settled on 01/31/2000, 06/15/2000, 01/15/2001, 01/17/2002, and finally 01/10/2003, the DSS will not contain any of these versions of settlements data (all created prior to 06/01/2003). However, if 01/21/2000 is re-settled again on 01/15/2004, the DSS will contain the entire data scope of settlements data.

Due to the DSS's phased release approach, some settlement days will therefore have an incomplete set of Customer Settlements data. The following bullets are a summary of settlements data contained in each release of the DSS. For days settled:

- ✤ Prior to 06/01/2003: DSS will contain no data created by BAS.
- Between 06/01/2003 and 10/05/2003: DSS will contain only data elements associated with the Balancing Market Energy and Uplift settlements.
- Between 10/05/2003 and 12/05/2003: DSS will contain only data elements associated with:
 - Balancing Market Energy and Uplift settlements
 - DAM Energy and Uplift settlements
 - Virtual Market settlements
 - Transmission Congestion Contract settlements
- ✤ After 12/05/2003: DSS will contain all in-scope data elements related to NYISO Customer Settlements.

- ✤ Release 2 on 06/05/2003

How to Use this Document

- ✤ If you know the Settlement Date and Invoice Version you wish to query:
 - Given the Settlement Date and Invoice Version of the data you are looking to query, determine the date the given data was created in BAS (billing run date). This date can be obtained by querying within DSS using data elements in the Invoice Version classes, specifically looking at the Invoice Billing Run Date data element. The Invoice Billing Run Date data element will provide the date that the data was created on in the BAS.
 - Using the Invoice Billing Run Date, compare against the given DSS Release Dates provide below to determine if the data would be either in the DSS, limited to a partial set of settlements, or excluded entirely. Again, any data that was created on or after the Release Date for the given Market Settlement will be in the DSS. Any data that was created prior to the Release Date for the given Market Settlement will not be in the DSS.
