Proposed Effective Date

The NYISO proposes to make this filing effective on May 31, 2000, the date of the Commission's Order ("the Order").

Names and Addresses of Persons to Whom a Copy of the Filing Has Been Mailed

A copy of the filing is being sent to all signatories to the NYISO Services Tariff.

Brief Description of the Revisions

For the reasons described in the next section hereof, the NYISO is making changes to its Services Tariff.

Statement of the Reasons for the Tariff Changes

- **A. Mandatory Bidding Requirements.** Revisions to pages 79 and 79A implement the provisions of the Order restricting the mandatory bid requirement to 10-minute non-spinning reserves facilities located east of the central-east constraint. Units that can demonstrate legal, environmental, physical or contractual requirements that restrict their bidding do not have to bid in the 10-minute non-spinning reserves market.¹
- **B. Setting Prices for Non-Spinning Reserves.** The NYISO has revised Rate Schedule 4, page 137A in particular, to clarify how prices are set in the non-spinning reserves market. Revisions to page 52 also provide detail on the determination of non-spinning reserves prices.
- **C. Price Caps.** The NYISO removes price caps in the spinning reserves markets with revisions to pages 138 and 139.

¹ The NYISO's March 27, 2000 filing revised tariff language that was in effect on that date. The Commission, on March 31, 2000, accepted another filing, filed February 1, 2000, that revised some of the same tariff provisions. The tariff revisions in this compliance filing modify the tariff as it was in effect on March 31, 2000.

- **D.** Payments for Lost Opportunity Costs. Pursuant to the Order, to replicate arrangements for suppliers of spinning reserves, page 147 is revised to provide for the payment of lost opportunity costs to suppliers of non-spinning reserves.
- **E. Grammatical and Stylistic Changes.** Several additional, non-substantive changes are proposed, dealing only with style and grammar. These changes are indicated in the redline comparison.

No Costs Relating to Discriminatory Employment Practices

The NYISO has no expenses or costs that have been alleged or judged to be illegal, duplicate, or unnecessary costs that are demonstrably the product of discriminatory employment practices.

Compliance With Order No. 614

The Commission's May 31, 2000 Order required this compliance filing within 15 days. Given the limited time period, the NYISO has complied with the Commission's new tariff designation rules for the sheets included in this filing. The NYISO has not had the opportunity to redesignate and redesign its entire tariff pursuant to the new rules.
