

# NYISO Business Issues Committee Meeting Minutes -- DRAFT

Wednesday, April 28, 2004

*Best Western, Albany, NY*

## 1. Welcome & Meeting Objectives

Wes Yeomans, Chair of Business Issues Committee (BIC) called the meeting to order at 10:03 AM and welcomed the members of BIC. Attendees introduced themselves, naming the organizations they represent.

## 2. Approval of March minutes Ray Stalter, NYISO

Final drafts of the minutes from February 18 were distributed to BIC members before the meeting.

### Motion #1:

## 3. Chair's Report

Wes Yeomans of National Grid noted that most Market Participants were represented at the Joint BOD/MC meeting in April. Market Participants requested more time with David Patton to review the State of the Market Report. Elaine Robinson of the NYISO confirmed that David Patton would be present at the June 4<sup>th</sup> MC meeting in New York City. Mr. Yeomans also recommended that Market Participants participate in the ESPWG to discuss long-term planning issues.

## 4. Market Operations Report

Chuck King of the NYISO presented the Market Operations report. All-in average costs for March were 34% lower than March 2003 due to lower fuel prices and moderate weather. Virtual Load/Supply bids increased during March, and the average price of natural gas was below kerosene and No. 2 fuel oil for the 2<sup>nd</sup> month in a row.

## 5. Regional Market Enhancements

Mr. King then moved on to present the Regional Market Enhancements report. Facilitated Checkout is still on track for a May deployment. The E-tagging project was deployed on April 25<sup>th</sup>. An agreement was reached with ISO-NE to eliminate export TSCs. A Virtual Regional Dispatch planning meeting was to take place with ISO-NE on April 29<sup>th</sup>, and Mr. King expected to be able to give a more detailed report on progress during May's meeting.

Howard Fromer of PSEG inquired as to whether SMD 2.0 and rate pancaking elimination will make VRD unnecessary. Mr. King noted that David Patton's report indicated that VRD would bring benefits above and beyond those realized by eliminating export TSCs, and that the NYISO would continue to pursue it.

Work on the Cross Sound Cable interim solution continues. The contract has not been finalized with the scheduling service vendor, but ~~work proceeds in good faith, and~~ the interim solution is on track to be deployed in time for Summer 2004. The long-term solution will be in place by Summer 2005.

Mr. King then presented more details concerning the elimination of Rate Pancaking. Agreement was achieved on April 21 between ISO-NE, NYISO, and state regulators, and the export TSC elimination is expected to take effect immediately with no phase-in provisions. Separate filings are anticipated in advance of ISO-NE's June 22<sup>nd</sup> compliance filing, so that the Rate Pancaking can be implemented ~~right away before the end of this year~~. The NYISO's preferred timeline is to file with FERC by the end of May. The PSC will allow for recovery of export fees through retail rates, and any savings realized will be passed along through retail rates.

Tim Bush of Navigant Consulting asked if the lost revenue would be applied to wholesale TSCs, and Mr. King indicated that NYISO staff would research the question and respond.

The total revenue ~~that needs to be recovered by TOS in New York State is recovery amount is estimated to be roughly \$12 million from ISO-NE to NYISO. The amount from NYISO to ISO-NE that would be saved is estimated to be approximately \$10 million.~~

Mr. King indicated that ISO-NE and NYISO agreed that reciprocity was an objective that they would follow in the process of eliminating rate pancaking. Matt Picardi of Coral Energy asked if the NYISO had considered differences in internal transmission rate structures between New England and New York in the context of these discussions. Mr. King replied that it had not, and that NYISO would look into the issue and report back.

Mark Younger of Slater Consulting requested that the NYISO provide examples to help illustrate the impact of these changes. Mr. King replied that staff would look into this.

Several market participants indicated that more time should be taken to absorb the ramifications of this change. Mr. King stated that he would bring the schedule back to NYISO management for discussion.

Mr. King then presented information concerning the recent E-tagging deployment. The project objectives were to ensure that the E-tag data accurately reflects NYISO bids and schedules, to reduce the burden on MPs when scheduling transactions, and improve coordination among control areas. Market Participants will benefit from accurate and meaningful response to E-tag requests from the NYISO, from automatic updates to E-tags to reflect NYISO schedules, and consistent NERC-compliant E-tags among control areas.

Mr. King added that AMP III and IV deployment will take place on April 29<sup>th</sup>, and will include full conduct and impact testing, automatic mitigation of DAM MinGen and startup bids, and temporal selectivity, i.e., mitigation will now take place only for hours that fail the tests rather than the entire day if any one hour fails tests.

### 6. Project Prioritization Team Report

Tim Schmehl of the NYISO presented the report. Mr. Schmehl indicated that SMD 2.0 and its related projects are the top priority at NYISO at present, with billing projects a close second. Documentum has been rolled out to Committee Support and Regulatory Affairs departments. Additional phases will include other departments at NYISO. Four projects have been completed to date in 2004, and three projects have been added; the current project portfolio contains 60 projects in all. Station Power Accounting, AMP IV, E-tagging, and Data Warehouse projects were all deployed in April. James Considine presented detailed results from the Fall 2003 survey concerning ratings on NYISO's project collaboration and delivery at the April PPT. Mr. Schmehl noted that the NYISO would improve communication and information dissemination concerning project status and budgets through the NYISO website.

### 7. Working Group Updates

**A. Billing and Accounting** (Chair: Kevin Kipers): Round 1 of Blackout Cost reimbursements appeared on the most recent invoice. Cost breakdowns have also been posted to the marketplace. Congestion shortfall calculations were reviewed. The NYISO plans to include this adjustment on the four-month bill for January 2004, and that it is unlikely that this adjustment will be included on the current month bill due to the labor intensive process to calculate the amounts. The Billing Simulator project was also discussed -- there will be no direct MP access to the Billing Simulator. The group will initiate discussions on drafting requirements on a billing testbed for MP use. The RJ Rudden Billing Cycle study has been issued and was discussed. BAWG has been asked by the NYISO Board of Directors to provide input on potentially implementing a four-month final bill during 2005. Final Bill Challenge data has been posted by NYISO. A technical bulletin will be issued describing settlement rules for Grandfathered Rights. NYISO will retire the LECG uplift monitoring report, as this data is now available in DSS.

**B. Electric System Planning (Joint OC/BIC WG)** (Chair: William Palazzo): Phase I implementation of initial planning process. Final draft report will be available in mid-May. PowerGem also presented its report on historical congestion for 2003. Phase II Comprehensive Planning Process. Market

Participants generally agreed to the list of Applicable Transmission Facilities for identification of reliability need. TOs made presentations on Cost Allocation/Recovery. General consensus was reached on the concept that beneficiaries would pay for reliability upgrades. Roles of PSC, NYISO and TOs for Regulated Backstop Response are still under discussion. Several market participants commented that there was a discrepancy in the methods used by ESPWG and David Patton to calculate historical congestion. NYISO staff will bring this concern to David Patton for resolution.

- C. Installed Capacity** (Chair: Howard Fromer): The ICAP WG received a briefing from Levitan & Assoc., which is conducting the independent review of the demand curve input assumptions. The report is on schedule, and the final report will be made to the NYISO in June.
- D. Interconnection Issues Task Force** (Glen Haake gave the report): NYISO staff presented the scope of work on how the report will be conducted to look at intra-zonal areas that may become constrained in the future. MP comments were requested on the scope, and on which areas should be included in the model. NYISO staff also reviewed the results of a NYSRC report that shows that Long Island has no deliverability issue at present.
- E. Market Structures** (Chair: Jim Scheiderich): Transmission Outage scheduling Tech Bulletin was discussed, and will be re-worked based on MP input. The Market Trials for SMD 2.0 and an IEEE paper on Combined-Cycle modeling were also discussed.
- F. Price Responsive Load** (Chair: Bob Loughney): DADRP changes were discussed, and the NYISO is reviewing MP comments that were received. The major item at the next meeting will be to extend the DADRP, and under what terms that extension would take place.
- G. Scheduling and Pricing** (Chair: Ray Kinney): No meeting was held since last BIC. Francis Pullaro of Strategic Energy requested that the minutes reflect that the NYISO had committed at the March 16<sup>th</sup> S&P WG meeting that a draft date for a con-op on would be given by the end of April. Ray Stalter took an action item to follow up on this issue.

### 8. New Business

Mr. Yeomans has received several calls from MPs requesting that the Credit Working Group be resurrected. NYISO staff will pursue.

Ms. Robinson requested that MPs review the NYISO Code of Conduct in advance of the NYISO's five-year anniversary, and propose any changes. S&P WG will take responsibility for this issue.
