- Identify key business drivers
- Validate previous commitments / assumptions
- Provide initial candidates for review / discussion
  - Internal NYISO business owners
  - Market Participants
- Develop initial concept / requirement definitions
  - Provide supporting estimates based on level of detail
- Determine resource capacity
  - Consider baseline work and infrastructure projects
- Finalize candidate set of projects and resulting deliverable milestones
