Resource Enrollment with Request for ACL Data Enrollment Period Closes – ACL Data Request Period Opens MP Accepts or Declines Resource with Request for ACL Data Aggregation Management Window Closes – ACL Data Request Period Closes

DRIS Auto Denies/Declines outstanding ACL Data Requests



Prerequisites to Accepting ACL Data Requests

- Prior to a MP accepting a resource with a Request for ACL Data in DRIS, the following must have occurred:
 - MP: Used Eligibility Import to determine that ACL data for the resource was available in DRIS (optional)
 - MP: Successfully imported a resource with a Request for ACL Data
 - NYISO: Approve or Deny associated Duplicate Enrollments or Monitored Field Requests, if any
 - DRIS: Enrollment period has closed

ACL Data Request – Fields

- Prior to accepting the ACL Data Request, MP will populate editable fields
 - Available fields based on Response Type
 - Editable Fields
 - Subscribed Load
 - Subscribed Gen
 - Incremental kW
 - Shutdown kW

Locked Fields

- MP Name
- Resource ID
- TO Account Number
- Resource Name
- Zone
- Response Type
- Gen Rating
- Calculated ACL
- Net ACL



ACL Data Request Validations – Program Subscribed Load

- Format: Numeric, kW
- Values based on Response Type:
 - B: Must be greater than or equal to zero
 - C: Must be greater than or equal to zero
 - G: Must be null or zero



ACL Data Request Validations – Program Subscribed Gen

- Format: Numeric, kW
- Values based on Response Type:
 - B: Must be greater than or equal to zero and less than generator name plate rating
 - C: Must be null or zero
 - G: Must be greater than or equal to zero and less than generator name plate rating



ACL Data Request Validations – Incremental kW

- Format: Numeric, kW
 - Required when enrolling with an Incremental ACL
- Values based on Calculated ACL value:
 - If Calculated ACL is less than 500 kW: Must be zero
 - If Calculated ACL is greater than or equal to 500 kW: Must be greater than or equal to 30% of Calculated ACL
 - Exceptions:
 - When value supplied is greater than 5 MW in Zone J or 10 MW in Zones A-I and K
 - When Declared Value is not changed, must be greater than or equal to 20% of Calculated ACL



ACL Data Request Validations – Shutdown kW

- Format: Numeric, kW
 - Required when enrolling with a SCR Change of Status
- Values based on Calculated ACL value and Request for ACL Data:
 - If Calculated ACL is less than 500 kW: Must be zero
 - If Calculated ACL is greater than or equal to 500 kW: Must be greater than or equal to 30% of Calculated ACL
 - Exception:
 - When value supplied is greater than 5 MW in Zone J or 10 MW in Zones A-I and K



Validating ACL Data Requests

- User selects "Approve", confirm
- Resource will be Enrolled
 - Metered Load values used to calculate ACL will be copied to the resource's enrollment record

 Enrollment of resource is pending due to a Monitored Field, Duplicate Enrollment or combination of these and Request for ACL Data

Awaiting MP Action (new)

 Enrollment of resource is awaiting decision of MP to accept the Request for ACL Data based on the ACL calculated from existing Metered Load Data available in DRIS

Approved

 Pending enrollment request has been approved by the NYISO or an ACL Data Request has been approved by the MP

Denied

 Pending enrollment for Monitored Field or Duplicate enrollment has been Denied by the NYISO or a Request for ACL Data has expired

Canceled

- Pending enrollment request has been Canceled by the MP
- Declined (new)
 - Request for ACL Data has been Declined by the MP

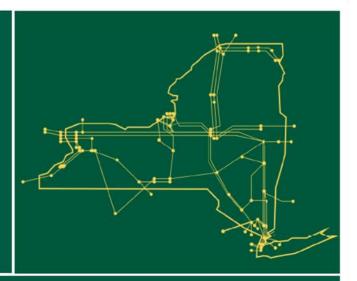
