Reference: Tariff revisions to NYISO's EDRP and SCR programs

Dear Ms. Kavanah:

On May 21, 2009 you submitted, on behalf of New York Independent System Operator, Inc. (NYISO), revised tariff sheets¹ to NYISO's Market Administration and Control Area Services Tariff. The revisions include, inter alia, proposed changes to (1) increase the period for the submission of Special Case Resources (SCR) and Emergency Demand Response Program (EDRP) performance data; (2) pay SCR for their participation in mandatory tests called by NYISO; (3) recover any overpayment to SCR through reducing future payments or through other lawful means; and (4) transfer temporarily SCRs whose capacity is unsold in the month to the EDRP for such month. The tariff sheets are accepted effective July 20, 2009, as requested.

Public notice of the filing was published in the Federal Register, 74 Fed. Reg. 26,391, with comments, protests, or interventions due on or before June 11, 2009. No protests or adverse comments were filed. Notices of interventions and unopposed timely filed motions to intervene are granted pursuant to the operation of Rule 214 of the Commission's Rules of Practice and Procedure 18 C.F.R. § 385.214 (2008). Any

opposed or untimely motion to intervene is governed by the provisions of Rule 214.

This acceptance for filing shall not be construed as constituting approval of any rate, charge, classification, or any rule, regulation, or practice affecting such rate or service provided for in the filed documents; nor shall such action be deemed as recognition of any claimed contractual right or obligation affecting or relating to such service or rate; and such acceptance is without prejudice to any findings or orders which have been or may hereafter be made by the Commission in any proceeding now pending or hereafter instituted by or against NYISO.

This order constitutes final agency action. Requests for rehearing by the Commission may be filed within 30 days of the date of issuance of this order, pursuant to 18 C.F.R. § 385.713.
