Dear Ms. Lampi:

On April 22, 2009, the New York Independent System Operator, Inc. (NYISO) submitted revised tariff sheets¹ to its Market Administration and Control Area Services Tariff and its Open Access Transmission Tariff. The revisions include: (1) amending the definition of Intermittent Power Resources to include electric facilities dependent on landfill gas as their fuel; (2) clarifying that Intermittent Power Resources are unable to accurately predict their real-time output; (3) clarifying that Compensable Overgeneration is applicable only to facilities that have offered their Energy in the NYISO market; and (4) to add a phrase that was inadvertently omitted from a recent filing. The tariff sheets are accepted effective, as requested.

Public notice of the filing was published in the Federal Register with comments, protests, or interventions due on or before May 13, 2009. No protests or adverse comments were filed. Notices of intervention and unopposed timely filed motions to intervene are granted pursuant to the operation of Rule 214 of the Commission's Rules of

Practice and Procedure (18 C.F.R. § 385.214). Any opposed or untimely motion to intervene is governed by the provisions of Rule 214.

This acceptance for filing shall not be construed as constituting approval of the referenced filing or of any rate, charge, classification or any rule, regulation or practice affecting such rate or service contained in your filing; nor shall such acceptance be deemed as recognition of any claimed contractual right or obligation associated therewith; and such acceptance is without prejudice to any findings or orders which have been or any which may hereafter be made by the Commission in any proceeding now pending or hereafter instituted by or against your company.

This order constitutes final agency action. Requests for rehearing by the Commission may be filed within 30 days of the date of issuance of this order, pursuant to 18 C.F.R. § 385.713.
