MINUTES OF THE MEETING

1. Introductions, Meeting Objectives & Chairman's Report

Chris Wentlent of AES, Co-Chairman, called the meeting to order at 10:03 AM and welcomed the members of the Management Committee ("MC"). The meeting objectives are to act on the November 10, 2004 minutes. Mr. Wentlent expressed his gratitude towards the MC members for the opportunity to serve as Chair. Mr. Wentlent commented that he hopes an environment of cooperation and productivity will continue going into the 2005 year.

Mr. Wentlent discussed the recent changes to the 2005 Committee Chairperson roster. The Budget, Standards & Performance Subcommittee ("BS&P") will be chaired by Rebecca Craft of Consolidated Edison. The Stay Review Subcommittee will be chaired by Paul Gioia of LeBoeuf Lamb Greene & MacRae LLP. The Market Participant Audit Advisory Subcommittee ("MPAAS") will be chaired by Bob Farrell of KeySpan Corporation. Mr. Wentlent stated that Neil Butterklee of Consolidated Edison who is the current chair of the ByLaws Subcommittee was willing to continue in the position if there were no other interested candidates. Mr. Wentlent requested that any interested candidates submit their names to Brad Kranz, otherwise he would appoint Mr. Butterklee to continue as the chair.

2. Approval of the Minutes

3. President's Report

William Museler of the NYISO commented that prices were slightly higher than November 2003, driven by fuel costs. The Environmental Advisory Council held its first meeting on November 18th. Members were recently added to the Council to provide

more strength to the group. The meeting was largely organizational in format. Air and water regulations in NY were also discussed. The council is open to having most future meetings open to Market Participants ("MP"), but still have a need for some private sessions. Meeting materials will be distributed after each meeting.

Howard Fromer of PSEG asked about the types of meetings and discussions that will be considered executive sessions.

Mr. Museler stated that the council needs the private time to discuss some matters.

Paul Gioia of the Transmission Owners asked for clarification on the defined relationship between the council and the NYISO. Mr. Museler committed to more information to the MP's regarding Mr. Gioia's question in writing by mid-January.

Jim Scheiderich of Select Energy asked for updates from discussions with the council that may impact market rules or regulations. Mr. Museler noted that the Environmental Council is not a policy making body and exists solely in an advisory role. Information that could impact market rules, policies or regulations will be made available to the MP's.

Mr. Museler noted that the NERC version "0" reliability standards are up for vote soon, and asked for participation from MPs in this vote.

Mr. Museler asked that MPs do their best to place bids in the SMD2 system as well as the legacy systems during the December 1 – December 10 parallel operations. The system will work without these bids, but a comparison of commitments and prices is not effective without MP participation.

4. Facilities Report

Mr. Museler mentioned that a cost comparison analysis of several scenarios was being conducted, and will be released on December 10. The BS&P will meet on December 13th, and a discussion will take place at this meeting. The NYISO is confident that the facilities consolidation is the right thing to do economically. Some material for the meeting may be sensitive and cannot be posted so MPs should try to attend.

5. SMD2 Readiness

Rich Dewey of the NYISO commented on NYISO Operator training, departmental readiness and SMD2 testing, deployment planning, LECG/Patton assessment, and a "Go-Live" consultation and notification schedule.

All operators have completed the two-week training cycle on the simulator. Operators will gain additional system exposure during the December parallel operation. Initial Business Owner / User Acceptance Testing has been completed. All departments will continue to validate and test SMD2 features and processes during parallel operation and the period up to deployment.

LECG has evaluated SMD2 performance and is prepared to declare SMD2 ready for deployment. LECG is scheduled to evaluate one remaining SMD2 feature next week. David Patton is reviewing the results of the test cases with Market Monitoring and has requested a few additional test cases prior to completing his readiness assessment.

Doreen Saia of Mirant asked if Mr. Patton will address the Marketplace with his assessment. At this time, Mr. Patton is not planning to address the Marketplace with his findings but his assessment will be released.

Additional meetings will be set up if necessary to keep the Marketplace informed of the SMD status.

Mr. Scheiderich asked if price data will be available to the MPs. Mr. Dewey stated that the prices will not be posted due to the fact that correlations will not be able to be made on the MP end. Mr. Scheiderich asked if there are any days where bid levels are acceptable in both systems, will the NYISO post the prices. Mr. Dewey stated that is possible, and consideration will be given to the question, but that is not planned at this time.

Parallel operations began for December 1st DAM evaluation. Operationally, no critical glitches were found. The SCUC and State Estimator programs are working well. The EMS and contingency analysis software is working well. Mr. Wentlent and Mr. Scheiderich emphasized the importance of placing bids in the SMD2 systems during parallel operations.

Mike Calimano of the NYISO stated that load bids are around 50-60% levels in SMD compared to Legacy. The NYISO is doing its best to place bids and make up differences where they exist between the two systems.

Mr. Museler commented in response to Alan Foster of Dynegy Power Marketing that the NYISO will be calling MPs to encourage parallel bids and will email the MC representative for an organization so they can reinforce the need for bids into the SMD2 system.

6. Billing Issues Update

Ken Davis of Hunton and Williams stated that the NYISO will issue the next eligible five months of invoices in January. Mr. Davis asked that MP's review the Billing Issues list, and that any questions arising from the review should be brought to the NYISO for resolution. The December9^{th,} BAWG meeting will discuss the list of outstanding items.

Paul Gioia commented that FERC requested a shortening of billing cycles, and asked if the NYISO was aware of this request. Mr. Davis commented that the NYISO is aware of this request. Mr. Museler commented that a straw-man proposal will be created and issued to the MP's to try to consolidate a joint response to the FERC.

Wes Yeomans of National Grid commented that it would be very helpful if the NYISO can post the manual adjustments out to the MP's as soon as possible.

7. New Business

Mr. Museler commented that the success of the NYISO at the 5th year anniversary was due to the MPs and NYISO staff. Mr. Museler expressed his gratitude to the MPs for their dedication.

Howard Fromer of PSEG asked for clarification on the posted revised NYISO/ISO-NE Seams agreement. Mr. Fromer commented that discussions with MP's should occur, so the NYISO accurately represents its customer's concerns when dealing with ISO-NE. Mr. Scheiderich commented that the Market Structures Working Group has discussed this issue in the past. Mr. Museler stated that input was received from MP's from all working levels regarding this issue.

8. Adjourn

The meeting adjourned at approximately 11:40AM.
