## **CROSS-SOUND SCHEDULED LINE TRANSACTION TIMELINE**

A Transmission Customer desiring to acquire an Advance Reservation must obtain the reservation from CSC, LLC and CSC, LLC must post the reservation on its Transmission Provider Page before ISO-NE will consider the associate external transaction within its scheduling process for the applicable dispatch hour(s).

### I. More than One Day Prior to the Operating Day

At least 7 days prior to the operating day:

Deadline by which holders of Advance Reservations must notify ISO-NE and CSC, LLC of their voluntary release of Cross-Sound Scheduled Line monthly transmission capability. Releases are posted on the CSC node of the NEPOOL OASIS shortly (minutes) after notice is provided to ISO-NE and CSC, LLC.

At least 3 days prior to the operating day:

Deadline by which holders of Advance Reservations must notify ISO-NE and CSC, LLC of their voluntary release of Cross-Sound Scheduled Line weekly transmission capability. Releases are posted on the CSC node of the NEPOOL OASIS shortly (minutes) after notice is provided to ISO-NE and CSC, LLC.

### **II.** One Day Prior to the Operating Day

- 4:50 a.m., day before the operating day: NY DAM closes to CSC bid submissions.
- 11:00 a.m., day before the operating day: NY DAM results are posted.

12:00 noon, day before the operating day:

- NE DAM closes. DAM bids for CSC External Transactions must be submitted in NE by this time. However, DAM bids/schedules in NE are purely financial and their submission **will not** prevent the default release of an associated Advance Reservation over the CSC. In order to avoid the default release of an Advance Reservation a bid over the CSC must be submitted to the NE RT market.
- NE RT market for dispatchable (price sensitive) transactions closes. Price sensitive RT bids for CSC External Transactions must be submitted in NE by this time. The submission of a dispatchable RT bid in NE by noon of the day prior to the operating day will prevent the default release of an Advance Reservation (in a MW amount equal to the bid, but not in excess of the capacity that is subject to the Advance Reservation) over the CSC. NE does not economically evaluate dispatchable RT bids until approximately 60 minutes before the appropriate dispatch hour.

# DRAFT, FOR DISCUSSION PURPOSES ONLY 12/13/04

- NE RT self-scheduled (price taker) transactions may be submitted at this time. The submission of a self-scheduled RT bid in NE by noon of the day prior to the operating day will prevent the default release of an Advance Reservation (in a MW amount equal to the bid, but not in excess of the capacity that is subject to the Advance Reservation) over the CSC. NE does not economically evaluate self-scheduled RT bids until approximately 60 minutes before the appropriate dispatch hour.
- Deadline by which holders of Advance Reservations must notify ISO-NE and CSC, LLC of their voluntary release of Cross-Sound Scheduled Line daily and hourly capability. Releases are posted by CSC, LLC on the CSC node of the NEPOOL OASIS shortly (minutes) after notice is provided to ISO-NE and CSC, LLC.
- Advance Reservations that (i) have not been voluntarily released by their holders, and (ii) are not the subject of a submitted dispatchable or self-scheduled RT bid in NE, are subject to the CSC default release rule and will be posted by CSC, LLC as default released Advance Reservations on the CSC node of the NEPOOL OASIS shortly (minutes) after noon of the day before the operating day. A Transmission Customer may then acquire an Advance Reservation under the default release process from the CSC, LLC and submit an associated self-scheduled RT bid in NE.

4:00 p.m. day before the operating day:

NE DAM results are posted. Again, NE DAM reservations do not affect Advance Reservations over the CSC.

### **III.** Operating Day

85 minutes prior to the dispatch hour: NY HAM closes to CSC bid submissions.

60 minutes prior to the dispatch hour:

- Deadline for submitting and/or modifying (increase or reduce MW) RT self scheduled transactions (price taker) in NE, including transactions over the CSC.
- Deadline for reducing previously submitted dispatchable (price sensitive) transactions in NE to 0 MW (canceling out the transaction).
- NE economic evaluation of RT bids (dispatchable and self-scheduled) occurs at this time.
- There is no default release of Advance Reservations within the dispatch hour.
