NYISO Management Committee Meeting Minutes

July 25, 2007 Conference Call 10:00 a.m. to 10:30 a.m. Minutes of the Meeting

1. Introductions, and Meeting Objectives and Chairman's Report

Mr. Picardi (Coral Power) called the meeting to order at 10:00 AM and welcomed the members of the MC. The members of the MC then identified themselves by market sector.

2. Approval of Minutes

Mr. Ray Stalter (NYISO) presented for approval the MC minutes from the June 12, 2007 meeting. He reported that no comments were received on these minutes distributed for MC review prior to the meeting, and asked if members had any comments. No comments or questions were raised. The minutes were then approved.

Motion #1:

Motion to approve the Minutes of the June 12, 2007 MC meeting. *Motion passed unanimously.*

3. President's Report.

Mr. Mark Lynch, President and CEO of the NYISO, discussed his monthly report, starting with the Price Correction Statistics pages. He noted that substantial progress has been made in June, with only 12 reservations and 2 corrections, while July through the 18th showed only 1 reservation and 1 correction. He ascribed this performance to transmission constraint pricing, improved operating procedures, and especially improved telemetry coverage. He also credited the efforts of the NYISO's Price Correction Elimination Team, which has worked to eliminate the root causes of price corrections.

Mr. Lynch then thanked those who participated in last month's joint NYISO Board/MC meeting and noted that the NYISO had received a lot of positive feedback with respect to the format, the location, and the NYISO's conduct of the meeting.

Mr. Lynch continued by noting that the NYISO will, over the next few months, be moving some large items through the governance process, and so will be seeking cooperation and input from the Market Participants (MPs). Examples of these issues include the demand curve reset, the FERC Order 890 Compliance Filing, the 2007 CRP and the 2008 RNA.

Mr. Howard Fromer (PSEG) expressed concern regarding the FERC 890 Compliance Filing and the NYISO's timeframe for meeting that obligation. He opined that it was unrealistic to expect that tariff language would be completed by the first week of October, which is the FERC deadline. He said it would be helpful for everyone involved to decide on the best course of action, as it wasn't likely that a good product could be developed in such a short time. Mr. Lynch responded by saying that Mr. Fromer's concerns were duly noted, but the NYISO felt it had a certain obligation with regards to compliance filings for FERC. Mr. Lynch noted this is one of the reasons he is soliciting the assistance of MPs for this and the other issues listed, but the intent of the NYISO is, by working with its stakeholders, to attempt to meet the associated deadlines.

Mr. Stuart Nachmias (Con Ed) said he agreed with what Mr. Lynch was saying, but that he also wanted to support Mr. Fromer to some degree. He said he thought they were relatively further along on reliability cost allocation, while some of the other components are more at the

"framework" level rather than the tariff language level. He opined that it wasn't clear that all of the elements had to be delivered at the tariff language level, and that perhaps the NYISO could make some determination as to what is required, so that reasonable goals could be developed for the October deadline. Mr. Lynch responded by saying that, as the NYISO worked through the stakeholder process, these types of issues could be explored; however, it was the NYISO's understanding the FERC would be looking for tariff language.

Dr. Kevin Jones (LIPA) said he agreed with Mr. Fromer and he was offering similar comments with regard to the "In-City Mitigation Order", and that there were a number of MPs who wanted to stay out of that proceeding as much as possible. He said he hoped that the NYISO's response to FERC is focused on In-City issues, with other NY areas left to the stakeholder process. Mr. Rob Fernandez (NYISO) said that has been the NYISO's intent all along, but that he heard Dr. Jones' concerns.

Mr. Neil Butterklee (Con Ed) said he believed that the NYISO's October FERC filing could be improved by having more stakeholder meetings specifically on what the markets will look like in the future. Mr. Fernandez replied that the comments received on this issue will be examined, and if it appears that face-to-face meetings would be productive they would be considered. He emphasized that what FERC was expecting was a fully supported filing, i.e., supported by evidence, economic theory, and the facts, and not merely a 58% vote. He concluded by repeating that whether one or more meetings were needed would be decided upon review of the comments received. Mr. Lynch noted that he had discussed this with Mr. Fernandez previously and that he supported this position.

4. Proposed Changes to Rate Schedule 2 of the NYISO Market Services Tariff re: Voltage Support Services (VSS)

Mr. Carl Patka (NYISO) presented his posted presentation on Voltage Support Service Rate Schedule 2 tariff cleanup changes. The intent, he noted, was to remove outdated and surplus language in the NYISO's Market Services Tariff (MST), the continuation of which could lead to confusion. No changes would be made to payments and associated agreements.

Mr. Patka discussed the history and details of the now outdated language. He continued by reading the two deleted MST passages on Slides 6 and 7, and concluded by noting that certain provisions no longer apply.

Other affected provisions are

- Most Purchase Power Agreements under PURPA and NY State Law have expired; (VSS payments now go directly to the generator).
- TOs that retain control over Non-Utility Generator (NUG) operations and related NYISO payments for NUG output become Financially Responsible Parties for the NUG (payments are made to TOs directly under these arrangements, not the Tariff).

The motion was moved and seconded.

Motion #2:

The Management Committee (MC) hereby recommends that the NYISO Board of Directors authorize the NYISO to file with the Federal Energy Regulatory Commission, pursuant to Section 205 of the Federal Power Act, Tariff revisions to VSS Rate Schedule 2 of the NYISO Market Service Tariff, as presented to the MC on July 25, 2007.

Motion passed unanimously with abstentions.

5. Budget & Priorities Working Group Update

Mr. Nachmias presented an update of the BPWG. At the most recent meeting in June, Mr. Rich Dewey of the NYISO presented an overview of the projects in the queue for 2008 and beyond. Work was continued on the project priorities list and the related budget impacts. Updates were given on the activities and needs of the different NYISO departments. Mr. Nachmias noted that the next meeting will be September 10, 2007, which is a change from the original schedule. The reason for this change is that is the date when the NYISO will have the first view of the 2008 budget. Mr. Nachmias expressed hope that as many MPs participate as possible in the fall meetings on the 2008 NYISO budget.

6. Board Selection Subcommittee Update

Mr. Picardi said that a list of potential board candidates was presented by the BSSC's consultant, Spencer Stuart. A list of candidates to be interviewed has been developed by the BSSC from the first list, with the interview dates to be in early August. Mr. Picardi concluded by saying the BSSC expects to have a list of three candidates for the MC to approve and thereby recommend to the NYISO Board at the August 29 meeting of the MC.

8. New Business

None submitted.

9. Adjourn
