# **Minutes of Meeting**

### I. Introduction and Meeting Objectives

Mr. Lou Rana, Chairman of the Management Committee (MC), called the meeting to order and welcomed the members of the Management Committee (MC).

Mr. Rana suggested the following objectives for the meeting:

- \* Action on proposed amendment to ISO Agreement addressing voting within the End Use Consumer Sector
- \* Status report on Stage I ICAP auction & market FERC filing
- \* Discussion regarding the roles of the Board, NYISO Committees, and NYISO Staff
- \* Action on motion concerning approval process for NYISO manuals
- \* Discussion of sector plans for the annual meeting.

# II. Approval of March 9, 2000 and March 20, 2000 Minutes

The Minutes of the March 9<sup>th</sup> and March 20th MC Meetings were approved.

### III. <u>Chairperson's Report</u>

Mr. Rana reported on the special Management Committee held on April 5<sup>th</sup> to review and prioritize the NYISO master project list. He indicated that the scopes and priorities of the existing projects were reviewed and that additional projects were noted. NYISO staff will amend the lists and re-issue the entire set of materials by April 14<sup>th</sup>. With regard to several concerns raised by Mr. Peter Brown, representing Aquila Energy, Mr. Scheiderich clarified that additional projects can be added to the list with the approval of a Committee Chair. Such additions would then be reviewed at the next regular committee meeting.

Mr. Rana requested that during the sector caucus, each sector should select a single representative to participate on the Stay Review Committee and to designate one or more individuals who will work with staff to coordinate the efforts of the (Budget and RTO), which have open membership.

Mr. Rana reported that since the FERC had acted on the Stage 1 ICAP filing, the March 30<sup>th</sup> MC meeting (Conference Call) was not needed and was subsequently canceled. Mr. Rana indicated that from time to time as needs arise, other emergency meeting and/or conference calls may be required.

# IV. <u>Resolution of Governance Issues Related to Participation of Governmental Entities that</u> <u>are Large Energy Users</u>

Mr. Leonard Singer of Couch White, representing Multiple Interveners (MI), provided an overview of the background and the work completed by the small group formed to address this issue. He indicated that the motion before the MC was a result of the compromise reached by the ad hoc group in which the ISO Agreement was modified to create a sub-sector of the end-use sector for large governmental agencies.

Mr. Rana noted the ad hoc group consisted of MI, Tariq Niazi of the Consumers Protection Board, MTA, City of New York, Judge Judith Lee of the NYPSC, Saul Rigberg of the NYPSC, Charles Kowalski of NYSERDA, John Reese of IPPNY, and James Schmidt and Ira Frielicher of Hunton and Williams. Mr. Rana commended the group for the excellent job in crafting and obtaining consensus on this issue.

Following discussion, Mr. Singer moved the motion #04-06-00-01, which was seconded and approved through a unanimous show of hands.

# V. ICAP Market and Auction for Summer 2000

Ms. Gina Fedele of Hunton and Williams provided a status update on the Stage 1 ICAP filing and auction. Ms. Fedele noted that the FERC had approved the Stage 1 filing and that the auction process stipulated in that filing had been implemented on April 1<sup>st</sup>, with the auction closing on April 3<sup>rd</sup>. Ms Fedele indicated that auction award notices were transmitted on April 5<sup>th</sup> with payment due on April 11<sup>th</sup>.

Mr. Bush of Sithe Energies inquired whether the clearing prices and transaction volumes had been posted on the web site. Ms. Fedele responded that the required information would be posted on April 6th.

# VI. <u>Reserve Market Discussion</u>

The status of this item was discussed in the Market Operation Report (agenda item VII).

# VII. <u>NYISO Market Operations Report</u>

Mr. Bill Museler, CEO of the NYISO, reported on the following topics:

\* The NYISO control performance improved and for the second straight month met NERC criteria with a measure of CPS2 of 98.3%.

\* Prices in the NYISO Reserve ancillary service markets have dramatically decreased. The decrease was attributed to the voluntary actions of certain MPs, and the provisions of the NYISO March 27<sup>th</sup> filing, which initiated a "cooling off" period supported by the NYISO Board and staff.

\*In accordance with the March 27<sup>th</sup> filing, Mr. Museler proposed a process for resolving design issues in the reserve market on a going forward basis. The MC, BIC and OC chairpersons support Mr. Museler's process proposal and indicated that a meeting of a joint working group will be convened. The working group will be asked to complete its assignment within 60 days.

\* The NYISO is continuing to work with suppliers to refine the 10 minute reserve price limits which are based upon demonstrated fuel commitment charges.

\* The participation in the NYISO markets continues with 98% of energy purchases being made in the DAM, with the remaining 2 % purchased in the real-time market. With regard to the DAM, 35% of the DAM energy was purchased in the LBMP market, with the remainder purchased though two-party bilateral transactions.

\* The NYISO continues its preparations for the Summer operating period. A list of the individual preparations will be distributed to the MC prior to the May MC meeting. Among the issues that will be addressed prior to Summer 2000 is the HQ import limitation.

Mr. Museler introduced Mr. Marc Rubin, General Auditor for the NYISO, and indicated that in addition to Marc's duties for the NYISO, that Marc also reports directly to the Audit Committee of the NYISO Board.

Mr. Charles King, NYISO Market Services, gave a brief update on the status of the billing re-runs that are presently under way at the NYISO. Mr. King noted that the multi-step settlement process described in the Retail Access Report (RAT) has been implemented, but is running between one (1) and (2) months behind the design schedule. He added that metering and telemetry anomalies have contributed to the delays, in addition to needed software enhancements and repairs. The NYISO is continuing to work with the TOs to research and resolve these problems. Mr. King indicated that the NYISO will also be adding additional hardware to provide the capability to process the re-runs in a shorter time and will be attempting to catch up to the original RAT design schedule over the next several months.

Mr. King summarized the highlights of the FERC RTO Workshop held in Philadelphia on March15-16th and the ISOMOU Business Practices Working Group Meeting held on March 30<sup>th</sup> in Wilmington Delaware. Mr. King reported that the Working Group meeting in Wilmington was open to all Market Participants with well over 100 persons in attendance. Mr. King noted that Mr. Ken Laughlin, Vice President of PJM Market Services, facilitated a group of Market Participants in a discussion of the process required for moving forward. The process recommendations which were proposed by this group included the continuance of open meetings and the use of the new web site (<u>www.ISOMOU.com</u>) as the primary vehicle for disseminating information. Mr. King urged the MC representatives to check this site often for future developments and postings regarding this work.

In addition to the process issues, Mr. King indicated that both short and long-term market & seams issues were reviewed and refined. Mr. Dave LaPlante, Vice President, Market Development, of ISO-NE, facilitated a group discussion of the short term issues, while Mr. King facilitated a parallel group discussing

long term issues. It was recognized that resolutions to many of the long term issues identified would likely be folded in to the regional RTO filings due to the FERC in January of 2001. Following the group discussions, both the long and short term issues were given relative priority rankings by those Market Participants who were present at the Working Group meeting. Mr. King indicated that future meetings would be announced through the ISOMOU website.

# VIII. Lunch and Sector Caucuses

Following the sector caucus, Mr. Rana queried each sector for its participants for the Stay Review, Budget & Standards subcommittees, and the RTO Working Group.

# IX. <u>Report on Discussions Concerning Roles of Board, Staff and Committees</u>

Mr. Harvey Reed, Vice Chairperson of the MC, reported on the progress of the ad hoc group which was formed as a result of the discussion of the 3-9-2000 MC meeting to address the roles of the NYISO Board, Staff, and Committees. Mr. Reed indicated that the participants on the group consist of himself, John Reese, Peter Brown, Lou Rana, Ira Freilicher, and Paul Gioia. Mr. Reed added that even though a consensus had not yet been reached, the group has concurred on a number of individual points.

1. NYISO Committees should work collaboratively and cooperatively to expeditiously resolve open issues.

2. In extent situations, the NYISO Staff must be able to take needed actions.

3. The NYISO Board has the absolute authority to resolve disputes.

Mr. Reed further described an interim solution that could be agreed upon until such time as the group reaches a consensus on all related issues.

- NYISO Staff should continue to facilitate committee work.
- Committees may vote on any matter put before them.
- The NYISO Board may overturn any decisions.

Mr. Reed indicated that the ad hoc group will continue to meet to resolve the remaining issues pertaining to the roles of the Board, Staff and Committees.

# X. <u>MP Oversight of NYISO Manuals</u>

Ms. Jacqueline Cochrane of Strategic Energy LLC reviewed the background of the motion regarding Market Participant oversight of the NYISO manuals which was distributed to the membership prior to the MC meeting. Ms. Cochrane indicated that her intent in drafting the motion was to preserve authority which was already documented in the NYISO's Documentation & Publication Manual that is published on the NYISO website. Mr. Rana suggested that other members of the MC participate in the next meeting of this group and Mr. Frielicher concurred.

# Motion :

Ms. Cochrane then brought motion #04-06-00-02 to the floor for discussion. The motion was seconded and following a review of the specific points contained in the motion by Ms. Cochrane, a number of Market Participants including Ms. Lampi of PACE Energy Project, Tim Bush of Sithe, and John Reese of IPPNY, expressed their concern that the terms of the motion will be overly constraining on the NYISO Staff and limit their ability to make needed changes in procedures in extent situations and consequently they were of the opinion that the maintenance of the manuals should remain under the preview of the NYISO Board and Staff. Other MC representatives including Tom Rudebusch representing MEUA, Jerry Ancona of Niagara

Mohawk, and Jim Parmelee representing LIPA, reiterated their concurrence with the major points in the motion including Committee approval of all substantive changes in the manuals. Mr. Parmelee suggested that all revised manuals be published with changes highlighted.

Mr. King, of NYISO Market Services, cited a recent example in which a procedure for updating the NYISO website was deemed by the Staff to require modification to be more responsive to Market Participant needs and noted that the needed change was not considered an emergency. Mr. King inquired whether the motion, as written, would preclude the NYISO from implementing the needed procedural change until the next regular committee meeting. Ms. Cochrane confirmed that the motion, as written, would preclude the NYISO from implementing the appropriate committee could vote to approve the proposed modification.

Mr. Bob Hiney of NYPA suggested that a workable process might include the provision of a consent agenda for manual changes which would allow the NYISO to make needed changes in a timely fashion and allow for full Committee review at the next regular MC meeting.

# Motion :

Following further discussion, Mr. Bush of Sithe Energies made a motion to table motion #04-06-00-02. The motion to table was seconded and passed with a vote of 61.33%/

Mr. Freilicher agreed to work with the ad hoc group formed to resolve the issues regarding the roles of the Board, Staff and Committees to redraft the motion for consideration at the next MC meeting.

# XI. Motion Concerning NYSRC Funding

Mr. Thomas Rudebusch, representing MEUA, requested that the motion #04-06-00-3 be tabled until the next regular MC meeting. There was no opposition to the request.

# XII. Annual Meeting

Mr. Garry Brown of Sithe Energies, reported on the preparations for the Annual Meeting with the NYISO Board. He noted that each sector would be allotted forty-five (45) minutes to discuss items of its choosing with the Board. Mr. Brown indicated that the agenda would be confirmed by April 7<sup>th</sup> and that Mr. Wiener would provide MC members with a letter providing additional details and arrangements for the meeting. Mr. Rana encouraged the MC representatives to utilize a portion of the sector caucus time to plan their use of their respective time slot for the meeting and that some thoughts and discussion should be focused on planning for the 1 to 3 year period of NYISO development.

# XIII. <u>New Business</u>

Mr. Rana indicated that based upon several inquiries he had received, there was a desire to alternate meeting locations between New York City and Albany. Mr. Rana suggested that a straw-vote be taken

to quantify the desire to hold one or more MC meetings in the Albany area. The results of the straw vote was 13 in favor of holding one or more meetings in Albany with 17 in favor of maintaining the MC meetings in NYC.

# XIV. Adjournment

A motion was made to adjourn the MC meeting at approximately 2:30 pm. The motion was seconded and approved by unanimous vote.
