Dear Ms. Burgess:

On October 19, 2015 TC Ravenswood, LLC provided notice to the New York State Public Service Commission ("NYPSC"), New York Independent System Operator ("NYISO"), The Consolidated Edison Company of New York, Inc. ("Con Edison"), and the New York State Reliability Council ("NYSRC") that it intends to mothball GT 4, 5 and 6 on or about April 30, 2016. TC Ravenswood was not informed that any of the GTs are required for reliability and accordingly they will be mothballed on April 30, 2016 and will not be offered into the May 2016 Capacity Spot Auction.

GTs 4, 5 and 6 commenced operations in 1970. Over the past 30 months, several operational and maintenance issues have occurred, including ongoing evaluation and repairs resulting from Hurricane Sandy. These units are reaching end of life unless substantial investment is made to numerous components. Such an investment is not economic at this time based on market conditions and environmental issues as well as other considerations including but not limited to various risks associated with operating and maintaining these older units. A similar vintage GT, #7, was previously mothballed after experiencing an over speed condition, high vibrations, a rotor ground and discovery of failed bolts in the turbine rotor first stage section.

TC Ravenswood will not be investing in these GTs at this time. If TC Ravenswood determines that the GTs will return to service in the future, it will notify all the parties to this notice prior to returning to service.
