Notice of Intent To Retire Ravenswood Gas Turbine Units

Dear Secretary Phillips:

In accordance with the Commission's Generating Unit Retirement Order¹ (the "Order"), Helix Ravenswood, LLC ("Ravenswood") hereby provides notice that it intends to cease operation and retire the below Ravenswood units on May 1, 2023. The Ravenswood gas turbine units are being retired pursuant to the New York State Department of Environmental Conservation Peaker Rule.²

The Ravenswood gas turbines ("GTs") began operation between 1967 and 1970, and have a combined nameplate rating of 68.6 MW. The units are interconnected to the Consolidated Edison Company of New York, Inc's ("Con Edison") system in the New York Independent System Operator's ("NYISO") load Zone J. A summary of the units is provided below.

Pursuant to the requirements of the NYISO, Ravenswood is submitting a Generator Deactivation Notice to the NYISO for the above listed Ravenswood units. Ravenswood is providing a copy of this notice to the NYISO and Con Edison in accordance with the Order and Technical Bulletin No. 185 issued by the NYISO. Ravenswood maintains all rights with respect to withdrawal of this notice in a timely manner should conditions warrant such action.
