Re: Notice of Intent to Retire National Grid Generation, LLC Glenwood GT Unit 1

Dear Secretary Phillips:

National Grid Generation, LLC, ("NGG") owns and operates steam generators and gas turbine units in accordance with the Amended & Restated Power Supply Agreement ("A&R PSA") with the Long Island Power Authority ("LIPA"). In accordance with A&R PSA provisions, LIPA and their agent, PSEG LI, have elected to retire the Glenwood GT Unit 1 (NYISO PTID 23712) effective February 28, 2021. Glenwood IC Unit 1, with a nameplate rating of 16 MW, is a gas turbine unit located in Glenwood Landing, New York.

Per the New York State Public Service Commission's *Generating Unit Retirement Order*¹, NGG hereby provides notice that it intends to retire operation of the Glenwood GT Unit 1 on February 28, 2021.

Pursuant to the requirements of the New York State Independent System Operator ("NYISO"), NGG is submitting a Generator Deactivation Notice to the NYISO for Glenwood IC Unit 1. NGG is providing a copy of this notice to the NYISO, LIPA, and PSEG-LI.
