Subject: Notice of Intent to Retire Nassau Cogeneration Unit 01

Dear Secretary Phillips:

In accordance with the Commission's *Generating Unit Retirement Order*<sup>1</sup>, Nassau Energy, LLC ("Nassau"), a wholly-owned subsidiary of ENGIE North America, Inc. ("ENGIE"), hereby provides notice that it intends to cease operation and retire Unit 01 at the Nassau facility on March 31, 2022, subject to the applicable STAR process and its outcome.

Nassau Cogeneration Unit 01 is a natural gas-fired cogeneration facility that began operating in 1991.

The unit is located in Nassau County New York, and is interconnected to the LIPA/PSEGLI transmission system in the New York Independent System Operator's ("NYISO") Zone J. The NYISO PTID and nameplate capability are as follows:

The state of the generating equipment itself requires mandatory and expensive capital upgrades to maintain reliability. Current power prices and forecasted market conditions in New York State are such that it is no longer economical for ENGIE to continue operating Unit 01.

Thus, because operating the facility is not currently economic and is not expected to be economic, ENGIE intends to retire the unit. Should circumstances change, ENGIE will notify all parties to this notice.

ENGIE is also providing a copy of this notice to the NYISO, LIPA and PSEGLI in accordance with the Order and Technical Bulletin No. 185 issued by the NYISO.
