RE: Filing of Revised Tariff Sheets that Update Creditworthiness Requirements

On June 16, 2004, the New York Independent System Operator, Inc. (NYISO) submitted for filing revised tariff sheets (as listed on the Attachment) updating its creditworthiness requirements. NYISO states that the revised sheets add a component to the Operating Requirement¹ so that certain transmission charges currently billed and collected by transmission owners will be addressed by the NYISO's customer creditworthiness requirements. NYISO states that these revisions will provide the necessary protection from default of transmission charges due to the transmission owners and clarification of the NYISO's authority to terminate customers who fail to pay certain transmission charges to the transmission owners. NYISO further states that the revisions clarify that the unsecured credit starting point for certain affiliated municipal electric systems is the aggregate of the unsecured credit starting points of its individual members. NYISO states that this revision makes explicit what the NYISO believes was implied in the existing tariffs.

Pursuant to authority delegated to the Director, Division of Tariffs and Market Development - East, under 18 C.F.R. 375.307, the NYISO's revised tariff sheets that update its creditworthiness requirements are accepted effective August 16, 2004, as requested.

Notice of the filing was published in the Federal Register with interventions, comments, or protests due on or before July 7, 2004. Under 18 C.F.R. 385.210, interventions are timely if made within the time prescribed by the Secretary. Under 18 C.F.R. 385.214, the filing of a timely motion to intervene makes the movant a party to the proceeding, if no answer in opposition is filed within fifteen days. The filing of a timely notice of intervention makes a State Commission a party to the proceeding. No adverse comments or protests were received.

¹ The Operating Requirement reflects the nonpayment exposure attributable to each customer based on the customer's activity in each of the NYISO's markets; there is an Energy and Ancillary Services component, an Unforced Capacity component, a Transmission Congestion Charge component, a Bid component, and a proposed Wholesale Transmission Services Charge component.

This action does not constitute approval of any service, rate, charge, classification, or any rule, regulation, contract, or practice affecting such rate or service provided for in the filed documents; nor shall such action be deemed as recognition of any claimed contractual right or obligation affecting or relating to such service or rate; and such action is without prejudice to any findings or orders which have been or may hereafter be made by the Commission in any proceeding now pending or hereafter instituted by or against NYISO.

This order constitutes final agency action. Requests for rehearing by the Commission may be filed within 30 days of the date of issuance of this order, pursuant to 18 C.F.R. 385.713.
