New York Independent System Operator, Inc., Docket No. ER07-570-000 Notice of Implementation of the Dennison Scheduled Line

Dear Ms. Bose:

On February 23, 2007 the New York Independent System Operator, Inc. ("NYISO") filed proposed revisions to its Open Access Transmission Tariff ("OATT") and Market Administration and Control Area Services Tariff ("Services Tariff") in which it sought to implement two new Scheduled Lines¹ -- the Dennison Scheduled Line and the Neptune Scheduled Line.² In its transmittal letter, the NYISO committed to providing two weeks' notice prior to implementation of each of these new Scheduled Lines to the Commission, all NYISO Market Participants, and the affected External Control Area operators.

In accordance with its commitment, the NYISO is providing the promised notice to the Commission, Hydro Quebec Energy Services, and Market Participants that it expects to deploy the software necessary to implement the Dennison Scheduled Line on or about May 1, 2007. This notice will be served on the official service list in this proceeding and will be posted on the NYISO's website. Should the NYISO determine that it will be unable to deploy the software on or about May 1, it will promptly notify the Commission, Hydro Quebec Energy Services, and its Market Participants.

This letter only addresses the implementation of the Dennison Scheduled Line. The NYISO will submit a separate notice to the Commission, Market Participants, and PJM Interconnection, LLC (the relevant External Control Area operator) two weeks in advance of its planned implementation of the Neptune Scheduled Line.
