## Jerry Ancona Responses to NYISO MC Nominating Committee Questions

## Ques. 1 - Please describe all experience you have had in chairing groups or committees of diverse interests, with a list of such groups.

I served as chairperson of the NYPP Member System Generation Issues Resolution Team (GIRT) for two years. This group (which - notwithstanding being comprised of Transmission Owners - still represented many diverse perspectives and concerns) managed to reach agreement on a large number of complex issues while trying to achieve balance between conflicting objectives. While serving as chairperson, GIRT completed extensive work to produce six NYISO manuals (many of which still remain largely unchanged), and it made the transition to "Open GIRT" to include all Market Participants in issue resolution. In a predecessor restructuring group with diverse interests and opinions, I co-chaired the New York PSC Competitive Opportunities Operating and Pricing Working Group "C" and co-authored a consensus final report. This group laid the initial groundwork for the ultimate development of the NYISO energy and ancillary services markets.

## Ques. 2 - Please describe the support of your organization for your assuming the position of Vice-Chairperson, and describe your ability to make the necessary time commitment.

I have the full support of my corporate management and my colleagues at work to contribute to the improvement of the NYISO and the competitive electricity market in New York State. I will invest the time, effort and imagination needed to make the Management Committee a success.

## Ques. 3 - Please describe any training or experience you have had in mediation, ADR (Alternative Dispute Resolution) or consensus building.

My formal training in mediation and ADR includes Niagara Mohawk seminars in Supervisory Skills, and team projects associated with my MBA graduate study at Syracuse University. Personal experience has taught me that true consensus is more communication and creativity than it is compromise or capitulation. Furthermore, I believe disagreements can frequently be resolved by building trust, reducing misinformation, and lightening the mood with some well placed humor.

### Ques. 4 - Please describe briefly why you would like this job.

I've served on effective teams and on ineffective teams. The resulting differences in synergy, growth, and accomplishments of the former compared to the latter were remarkable. I believe that I can be a catalyst to help the Management Committee be as productive and relevant as it possibly can.
