NYISO Management Committee Meeting Minutes

1. Introductions, Meeting Objectives, and Chairman's Report

Mr. Matt Picardi (Coral Power), Chairman, called the meeting to order at 10 AM and welcomed the members of the MC. He noted that the only actions items for this meeting were the approval of the minutes for April 30 and May 21, 2007. The members of the MC, NYISO staff, and representatives of FERC and the PSC then identified themselves.

2. Approval of the Minutes

Mr. Ray Stalter of the NYISO presented the MC minutes from both the April 30, 2007 conference call and May 21, 2007 MC meeting for approval. He noted that the April 30 minutes distributed prior to this meeting contained comments recently received. He asked for additional comments from the Committee on both sets of minutes. No additional comments were provided. Both sets of minutes were then jointly moved for approval.

Motion #1:

Motion to approve the Minutes of the April 30, 2007 and May 21, 2007 MC meetings. *Motion passed unanimously.*

3. President's Report

Mr. Garry Brown of the NYISO presented the Report for Mr. Mark Lynch, who was attending the NYISO Board of Directors meeting. He thanked the companies who donated prizes for the events of the prior day. He then went on to discuss the NYISO's new Conference Center at Krey Boulevard (the KCC), and the notification process for attending meetings at that facility. In response to questions from multiple members, a discussion was held regarding what to expect with respect to gaining entrance to the KCC without 24 hours notice. Mr. Brown and Mr. Stalter noted that with the requested 24-hour RSVP the system for creating badges should run smoothly, but also that the NYISO was open to suggestions for improvements. Mr. Stalter asked that suggestions should be sent via email to him.

For the President's Report, Mr. Brown noted that all the usual information such as the price correction and market performance highlights were in the Report, and asked if there were any comments. None were offered.

Mr. Bruce Bleiweis of DC Energy asked if uplift was to be discussed as it was a topic of concern at the most recent BIC meeting. Mr. Stalter responded that the issue was still under review and would be followed up on at an upcoming meeting.

4. Recap on Joint Board/MC Meeting

Mr. Brown discussed the genesis of the format used this year which allowed for more members to participate than in past meetings and then asked for comments:

Mr. Bleiweis said that one thought would be to have the social events on the first day, with a longer panel session on the second day to allow for more discussion of the issues.

Mr. Glenn Haake of IPPNY said he liked the give-and-take nature of yesterday's session, but would have preferred to have covered more of the issues and questions listed. A discussion followed about possible adjustments for next year's meeting.

5. FERC Update

Mr. Larry Gasteiger of the FERC thanked the members for their hospitality and noted that any comments he would be making were his alone and would not necessarily reflect the views of FERC.

After reviewing his professional background, Mr. Gasteiger discussed some of the broader themes of FERC activities. The paramount issues were those related to competition in the energy markets. He went on to say that competition in the wholesale markets has not been a creation of FERC policy, but rather a national policy for the past couple of decades, and has been subject to extensive regulation. A primary focus of FERC has been to support and improve competitive markets where they exist.

Other FERC efforts have included reforming the pro-forma OATT, which culminated in Order 890. Associated compliance filings are and will continue to be sent into FERC throughout the course of this year.

Another area that FERC is taking a hard look at is Market-Based Rates (MBR). The Commission has modified its test for MBR authority and has shown a willingness to revoke MBR authority for entities found to have market power.

Infrastructure improvements, i.e., building more transmission facilities, are another high priority for FERC, which has provided incentives to that end, such as CWIP and higher ROE's (Return On Equity), Mr. Gasteiger noted.

Continuing, Mr. Gasteiger said that reliability of the grid has been and will continue to be a priority for FERC, which has certified NERC as the ERO, and established regional entities to work with FERC for enforcing reliability rules.

As for enforcement authority, Mr. Gasteiger noted that FERC has not been shy about using its new penalty authority, (granted in EPAct 2005), in appropriate circumstances, which could be expected to continue to into the future.

The last subject he covered was the interaction between market participants and his office. He encouraged everyone to meet with him and his staff prior to either Section 205 filings or Section 206 complaints, which he said was beneficial to all sides and also saves time through improved communication.

Mr. Picardi asked about "self-reporting" and the associated penalties which he opined have been the subject of some concern in the market. Mr. Gasteiger responded that he did not work in the enforcement area at FERC, and so could not provide insight as to how the penalties were arrived at. He said that there is a related policy statement that FERC put forth, and his personal observation was that without the self-reporting, penalties would have been higher.

Mr. Stuart Nachmias of Con Ed asked about transmission development versus generation and demandside management alternatives. Mr. Gasteiger said that FERC did not have any particular view as to what the mix of such projects should be for any particular region; Order 679 was specific regarding incentives for transmission projects only.

Mr. Brown asked about capacity structures as developed within the different ISOs/RTOs and consistency of market rules. Mr. Gasteiger said his only response was that FERC sought to be flexible, and that it was important to be able to fully explain to FERC how you developed your market rules, especially in light of the thin straw-man proposals seen in other regions.

Mr. Howard Fromer of PSEG said he thought it would be helpful if Mr. Gasteiger could convey to the Commission a sense of urgency regarding the "in-city" capacity markets and the associated FERC procedural order, as without clarity there is a negative effect on the market. Mr. Gasteiger said that he would take back the comment as a procedural comment.

6. NYS PSC Update

Mr. Raj Addepalli of the New York State Department of Public Service (PSC) gave an update on key PSC electric cases via his posted presentation.

The first case had to do with pricing for retail customers. The PSC decided that utilities should continue to provide stable rates for mass market customers. They should develop price volatility metrics and guidelines for limiting volatility, and provide aggregate supply portfolio price information on a quarterly basis. Also, the value of hedges entered into by utilities should be flowed through utility commodity rates. This case is now in a compliance phase.

In another case, the PSC issued 11 questions for comment regarding the role of integrated, statewide resource planning and long-term contracts. Comments on the questions and issues were filed by 28 parties on June 5, 2007, with reply comments due June 25, 2007. Mr. Addepalli continued on these subjects in some detail. The three major themes include; should there be a statewide long-term resource planning process, should the PSC encourage long-term contracts by utilities and others to facilitate new generation, and how would such a process harmonize with the current NYISO market.

The third case was the Energy Efficiency Portfolio Standards case, wherein the PSC instituted a proceeding in May 2007 to establish an energy efficiency portfolio standard, with the goal of reducing New York's electricity usage by 15% by 2015. PSC staff is directed to immediately prepare energy efficiency program design proposals, with a report from the ALJ by June 29, 2007.

Other cases presented by Mr. Addepalli included the Revenue Decoupling Mechanism Case, which would develop ways to encourage utilities to develop energy efficiency, renewable technologies, and distributed generation through improved rate designs. Separately, work on Mandatory Hourly Pricing for certain rate classes continues, and utilities have filed related studies in preparation for implementation, past and future.

Also, there was the Advanced Metering Initiative Case (2006), where a policy was developed to encourage customer meter ownership, and competitive electric meter services, among other changes.

The Review of Retail Access Policies Case included a proceeding in April to review retail access policies and practices intended to foster the development of competitive retail energy markets. This review includes examining the costs and benefits of these policies and practices. Comments from the parties in the case are due June 21, 2007.

Mr. Addepalli concluded with the status of the Renewable Portfolio Standard (RPS) and its associated milestones related to energy projects, with the goal of 25% of the state's electricity being produced by renewable energy resources.

There followed a short discussion on energy efficiency v. reliability planning, long-term contracts, and the need for a comprehensive planning process, as well as the expected timeframes for associated PSC decisions.

7. Board Selection Subcommittee (BSSC) Update

Mr. Picardi provided an update on the BSSC activities. He noted that the expectation was to provide the NYISO Board with a list of recommended candidates by September 1, 2007. At the direction of the BSSC, he and Mr. Stalter interviewed a two search firms, and reported the findings of those discussions to the Subcommittee. The BSSC has chosen a search firm, and will announce that choice after an agreement with the firm is reached. Mr. Brown reminded the MC that the search was for a candidate with electric utility experience. Mr. Picardi concluded by noting that the public notice period for potential candidates to submit resumes would only be about 2-3 weeks, and asked the Committee if there were any concerns with that timeframe. No concerns were raised by the Committee.
