II. Motion To Intervene

The NYISO is the independent body responsible for providing open-access transmission service, maintaining reliability, and administering competitive wholesale electricity markets in New York State. A Commission order on the PJM filing could establish principles for ITCs operating in regions, such as New York, that have market designs similar or identical to the Commission's Standard Market Design, and thus could have a significant effect on the NYISO's operations. The NYISO therefore has a direct and substantial interest in this proceeding. This interest cannot be adequately represented by any other party, and the NYISO should thus be permitted to intervene herein.

The NYISO respectfully asks that the Commission grant its motion to intervene in this proceeding.
