Further, and as indicated at the meeting, there are open dockets at FERC relating to various tariff provisions identified below. Please also be aware that, as with any other tariff, the rules identified below are subject to revision.

The NYISO is continuing to review FERC's RMR Order¹ and the NYISO's current tariff provisions that may intersect with or be implicated by the Order. These provisions may include but are not limited to the following OATT Attachment Y Sections: Section 31.1 Definitions, Section 31.2 Reliability Planning Process, Section 31.5 Cost Allocation, and Rate Schedule 10.
