Background

- ◆ **As part of preparing for the anticipated evaluation of Incremental TCCs for the Transmission Owner Transmission Solutions (TOTS) projects, the NYISO discovered that the Section 6.4.1 of the TCC Manual addressing the effective date of temporary awards of Incremental TCCs:**
 - *Is not consistent with Section 19.2.4.5.1 of Attachment M of the Open Access Transmission Tariff (OATT); and*
 - *Requires a strict ten business day “waiting period” that is no longer necessary*

TCC Manual Update

- ◆ The NYISO proposes to revise Section 6.4.1 of the TCC Manual as follows:
 - *The temporary award begins from a date (“the effective date”) which shall be no earlier than ~~ten business days following the date the NYISO was notified of the actual commercial operation date and the developer has accepted its award through the submission of Attachment Q (but in no case earlier than the actual commercial operation date).~~*

TCC Manual Update (cont'd)

- ◆ **Consistent with the OATT, the proposed revisions to Section 6.4.1 of the TCC Manual clarify that:**
 - *Temporary awards of Incremental TCCs will now be allowed to become effective as early as the date of actual commercial operation of the Expansion at issue without requiring a ten business day waiting period*
 - *The date Attachment Q of the TCC Manual is submitted by the developer of the relevant Expansion will no longer impact the effective date of temporary awards of Incremental TCCs*

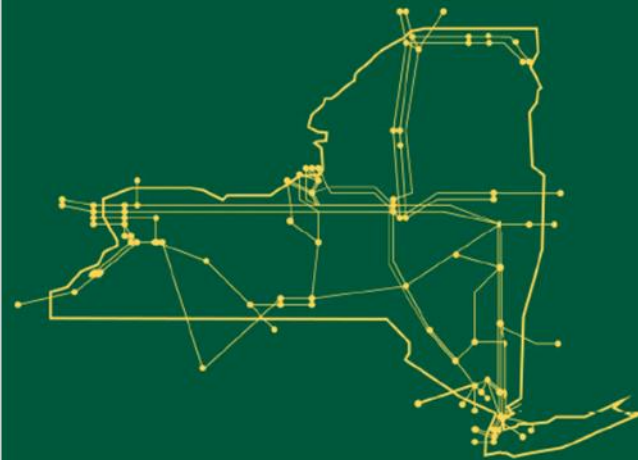
Technical Bulletin 236

- ◆ **Technical Bulletin 236 was created to clarify the effective date of temporary awards of Incremental TCCs during the period in which revisions to the TCC Manual are completing review through the shared governance process**
 - *Posted on June 14, 2016*
 - *Comments were due by June 21, 2016*
- ◆ **This Technical Bulletin will be retired when the TCC Manual updates become effective**

Next Steps

- ◆ **July 2016 BIC**
 - *Seek stakeholder approval of the proposed revisions to Section 6.4.1 of the TCC Manual*
