Reference: Deferment of Tariff changes

Dear Ms Lampi:

On August 18, 2008, the New York Independent System Operator, Inc. (NYISO) filed revisions to the NYISO's Day-Ahead Security Constrained Unit Commitment (SCUC) process in order to improve the efficiency of its resource commitment process.¹ The Commission accepted these revisions in a September 18, 2008 letter order.² On October 28, 2008 (October 28 Filing) NYISO filed to defer the effective date of tariff revisions that were accepted in the September 18, 2008 order. On January 14, 2009 NYISO filed an amendment to its October 28 Filing requesting that the tariff revisions be deferred until a time to be determined by NYISO. On February 4, 2009 NYISO provided notice that it intends to implement the tariff revisions under discussion here on February 12, 2009. Pursuant to authority delegated to the Director, Division of Tariff and Market Development - East, under 18 C.F.R. 375.307, your submittals to defer the effective date of the tariff revisions to February 12, 2009 are accepted.

Public notice of NYISO's October 28 and January 14, 2008 filings was issued on January 21, 2009 with comments, protests or interventions due on or before February 4, 2009. None were filed.

This order constitutes final agency action. Requests for rehearing by the Commission may be filed within 30 days of the date of issuance of this order, pursuant to 18 C.F.R. § 385.713.
