

Market Performance Highlights for February 2017

- LBMP for February is \$30.95/MWh; lower than \$40.07/MWh in January 2017 and higher than \$28.71/MWh in February 2016.
 - Day Ahead and Real Time Load Weighted LBMPs are lower compared to January.
- February 2017 average year-to-date monthly cost of \$38.02/MWh is a 12% increase from \$34.02/MWh in February 2016.
- Average daily sendout is 418 GWh/day in February; lower than 431 GWh/day in January 2017 and 436 GWh/day in February 2016.
- Natural gas prices were lower and distillate prices were higher compared to the previous month.
 - Natural Gas (Transco Z6 NY) was \$2.83/MMBtu, down from \$3.82/MMBtu in January.
 - Natural gas prices are down 6.1% year-over-year.
 - Jet Kerosene Gulf Coast was \$11.48/MMBtu, up from \$11.24/MMBtu in January.
 - Ultra Low Sulfur No.2 Diesel NY Harbor was \$11.63/MMBtu, up from \$11.61/MMBtu in January.
 - Distillate prices are up 57.9% year-over-year.
- Uplift per MWh is higher compared to the previous month.
 - Uplift (not including NYISO cost of operations) is (\$0.54)/MWh; higher than (\$0.73)/MWh in January.
 - Local Reliability Share is \$0.13/MWh, higher than \$0.10/MWh in January.
 - Statewide Share is (\$0.67)/MWh, higher than (\$0.83)/MWh in January.
 - TSA \$ per NYC MWh is \$0.00/MWh.
 - Total uplift costs (Schedule 1 components including NYISO Cost of Operations) are higher than January.



DAM Bid Production Cost Guarantees for Virtual Transactions are included in the chart and are shown from the inception of Virtual Transactions. These values are small and cannot be identified on the chart. DAM residuals consist of both energy and loss revenue collections and payments. By design, there is a net over collection of revenues due to the difference between the marginal losses paid to generation and the average losses charged to loads.







Hudson Valley Zone G Monthly Average LBMP Prices 2016 - 2017



NYISO Virtual Trading Average MWh per day





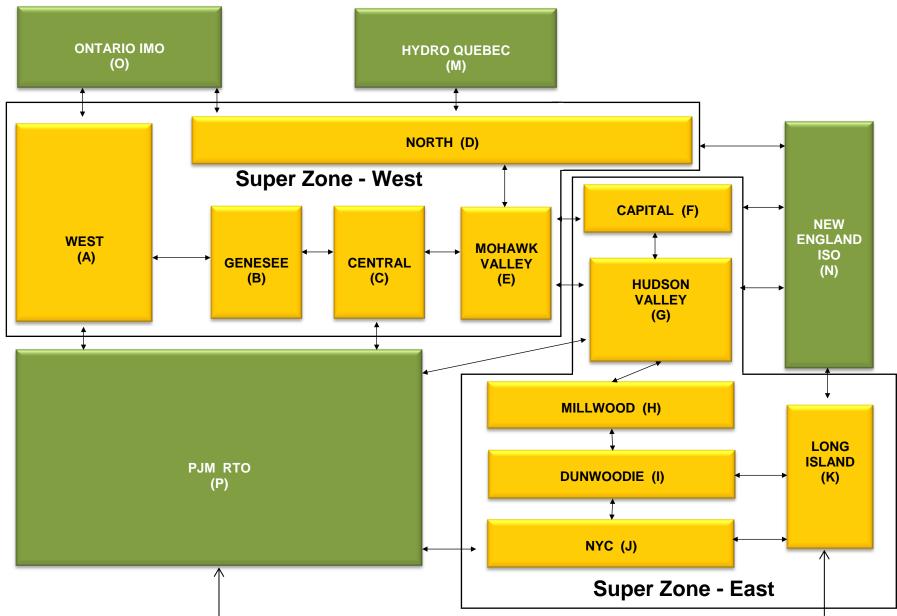








NYISO LBMP ZONES
