Motion #1:

IT IS HEREBY MOVED that the appeal by NRG Energy, Inc. of the Operating Committee's February 27, 2009 action denying approval of the Berrians GT III System Reliability Impact Study ("SRIS") be granted and the SRIS, as presented at the February 27, 2009 Operating Committee meeting for Q#266 - Berrians GT III is approved.

The Management Committee (MC) hereby recommends that the NYISO Board of Directors authorize the NYISO to file with the Federal Energy Regulatory Commission (FERC), pursuant to Section 205 of the Federal Power Act, to approve revisions to the NYISO's tariffs to enhance the creditworthiness policies for municipalities, pursuant to the presentation made to the Management Committee this date.

Motion #3:

The Management Committee (MC) approves the Voltage Support Tariff revisions, as presented to the MC on April 23, 2009.

Motion #4:

Motion to recommend that the Board of Directors approve the NYISO 2009 Comprehensive Reliability Plan (CRP) as presented by the NYISO and amended by the Management Committee at its April 23, 2009 meeting. The 2009 CRP was the subject of prior review and action by the Operating Committee at its March 12, 2009 meeting, at which the Operating Committee voted in favor of a motion recommending that the Management Committee recommend approval by the Board of Directors. The 2009 CRP was also the subject of prior review by the Electric System Planning Working Group and the Transmission Planning Advisory Subcommittee.
