Motion #3:

The Business Issues Committee hereby recommends that the Management Committee approve the changes to the NYISO's Open Access Transmission Tariff and the Market Administration and Control Area Services Tariff to adopt procedures in its tariffs for the assignment and collection of the costs of penalties levied against the NYISO by NERC and other regulatory authorities, pursuant to the presentation made and as revised at the Business Issues Committee meeting held on December 17, 2008, to provide that the allocation method for a penalty that is allocated pro rata to all customers shall be based upon 50% to MWh injections and 50% to MWh withdrawals. *Motion passed with abstentions.*

Motion #4:

The Business Issues Committee hereby recommends that the Management Committee approve revisions to improve and clarify the billing and payment provisions of the NYISO tariffs as is more fully described in the presentation made to the Business Issues Committee meeting on December 17, 2008. *Motion passed unanimously.*
