2. LSE shall pay to the NYISO (or, if applicable, be paid) the purchase price for the Historic Fixed Price TCCs acquired pursuant to this declaration as described in Section 19.2.1 of Attachment M of the OATT;
3. LSE shall comply with the NYISO's credit requirements to the extent applicable in connection with the Historic Fixed Price TCCs acquired pursuant to this request ;
4. if the NYISO concludes that LSE's requested conversion would make an existing and valid TCC infeasible, the NYISO will reduce the number of Historic Fixed Price TCCs that LSE may obtain as described in Section 19.2.1 of Attachment M of the OATT; and
5. all other provisions of the OATT and Services Tariff and of the ISO Procedures (as each may be amended) shall apply to the conversion of the ETAs, the resulting Historic Fixed Price TCCs, and other related issues.
