## <u>Motion #3b</u>

The Business Issues Committee hereby approves revisions to the NYISO's Ancillary Services Manual to the extent that a transmission owner needs additional time or equipment to accommodate Demand Side Management providers qualifying to supply ancillary services pursuant to NYISO tariff, NYISO will: (1) modify it's manual to provide for the additional implementation time: and (2) file an amendment to its tariff under FERC to provide for the recovery of all costs incurred by a transmission owner to accommodate the new provider.
