### **Draft MINUTES OF THE MEETING**

#### **1. Introduction and Meeting Objectives**

Joe Oates called the meeting to order at 10:02 AM and welcomed the members of the Management Committee ("MC").

Mr. Oates explained the objective for today's meeting is to consider and vote on SMD Real Time Scheduling ("RTS") tariff revisions.

#### **2. Overview of Standard Market Design ("SMD") 2 – RTS Tariff Revisions**

Ted Murphy, of Hunton and Williams, reported on revisions that have been made to SMD2 tariff language. All language is posted on the NYISO website under OASIS-SMD2 website.

Jim Savitt then stated that the specific methodology and numbers used to determine the time-of-day adder for startup reference levels did not belong in the Tariff (Attachment H). He said that such technical details were more properly articulated in a technical bulletin. He said that he would be bringing more details on the startup adder calculation to the AMP / in-City Task Force.

In response to a question, Rob Pike confirmed that the ISO would continue to explore the capabilities for off-dispatch units to be economically scheduled by RTC without having to be on-dispatch.

Mr. Murphy confirmed that the filing letter would state that there are placeholders in the tariff that would allow Demand Side Resources to provide non-synchronized operating reserves once certain software issues are addressed, and that the NYISO will initiate discussions aimed at allowing Demand Side Resources to provide other ancillary services in the event that the Reliability Rules are revised to permit it.

Mr. Bush stated that he continues to have concerns about the design of RTD-CAM, as it relates to the re-establishment of spinning reserve following a unit loss. Mollie Lampi confirmed that the NYISO will continue to discuss the design of RTD-CAM with Market

Participants and would pursue further design and / or tariff changes at the appropriate time if necessary.

Howard Fromer, of PSEG Energy Resources, noted that there is a NYISO position paper that addresses this issue included with today's meeting materials.

Ms. Lampi noted that the final tariff sheets will be posted five (5) days prior to filing with FERC to allow MPs a chance to identify changes which are expected to be only ministerial. The three committee chairs (MC, BIC and OC) will review these ministerial changes prior to filing.

Ms. Lampi agreed that the NYISO would post a clean copy of the tariff to the Web.

Mark Younger proposed additional language to the motion that provides for final approval of tariff language by the committee chairs prior to filing.
