### **NYISO Business Issues Committee Meeting Minutes**

NYS Nurses' Association, 11 Cornell Road, Albany, NY 12110

#### I. Welcome and Meeting Objectives

Mr. Wesley Yeomans, Vice Chair of the Business Issues Committee (BIC), called the meeting to order at 10:02 A.M. and welcomed the members of the BIC. The attendees introduced themselves and named the companies that they represent. Mr. Yeomans reviewed the list of agenda items and meeting objectives.

#### II. Approval of Minutes

Prior to the meeting, BIC members received the latest draft of the December 13, 2002 Meeting Minutes for their review and approval. It included revisions that were previously suggested from several Market Participants. While considering approval of these minutes, a few BIC members requested some additional editorial modifications. Ms. Elaine Robinson, of the NYISO, also informed the BIC members of her editorial requests. The Committee accepted these changes and unanimously approved the 12/13/02 Minutes.

#### Motion #1:

Motion to approve the minutes from the December 13, 2002 Business Issues Committee Meeting.

#### III. Chair's Report

As part of the January Chair's Report, Mr. Yeomans informed the BIC Members that Howard Fromer is succeeding Matthew Picardi as Chair of the Installed Capacity (ICAP) Working Group.

#### IV. Market Operations Report

Mr. Charles King, of the NYISO, explained that for future Market Operations Reports, his presentations will highlight significant items in the report, rather than review each graph. He did note that all graphs will continue to be included in future handouts. The December 2002 NYISO Market Performance Highlights indicate the following: real-time price corrections remain at very low pre-load pocket levels and are expected to remain at this level; the amount of uplift has steadily decreased since June – which reflects the Out of Merit Generation situation subsiding; and the total market costs have increased slightly since November because of increased fuel prices, reserve costs, and energy costs.

Mr. Stuart Nachmias, of Con Edison, suggested that it would be useful for the BIC members to receive the packet of graphs before the BIC meetings since only summaries are planned for future meetings. Mr. King pointed out that these graphs are identical to the ones used in the Management Committee (MC) meetings. However, since the MC meets after BIC, Mr. King noted that they would try to post the material as soon as the final billing data is settled each month.

Mr. James Scheiderich, of Select Energy, asked for details on how much the increased energy costs will be offset by the reduced uplift charges. Mr. King replied that the NYISO is still conducting an analysis and looking to see if any details can be broken out.

#### V. Spring 2003 Transmission Congestion Contract (TCC) Auction Plan

Mr. King offered a summary of the number of outstanding TCCs at the start of the auction and presented the Committee with an overview of the Spring 2003 Initial TCC Auction Plan and Schedule.

Mr. Garry Brown, of Sithe, asked about the possibility of the NYISO providing the transmission outage schedule prior to the start of the TCC Auction. Mr. Scheiderich noted that he planned to discuss it in his upcoming MSWG report.

Ms. Doreen Saia, representing Mirant, requested that the NYISO communicate the results of discussions that were occurring concerning the 1385 line and feasibility. The NYISO agreed to take this on as an action item.

#### VI. Seams Status

Mr. King informed the Committee that the NYISO met with the FERC in Washington, D.C., January 15th, to discuss the Seams Report. The report focused on past achievements and future plans. He noted that the report was well received by the FERC and it's posted on the NYISO Website. He also mentioned that FERC focused on the Rate Pancaking Issue and that Mr. Museler suggested holding a Technical Conference to to move the issue forward. The Congestion Management Pilot that the NYISO implemented with PJM was also discussed with FERC. It had been implemented six times. The Congestion Protocol that PJM proposes to use with the Midwest ISO is based on this pilot.

Mr. Nachmias requested that Mr. King summarize the NYISO's plans for coordinating Data Warehouses with other ISOs. Mr. King took this on as an action item for Ken Fell.

Mr. Rick Mancini, of NYSEG, inquired about the status of the Ramp Rate Issue from November's BIC Meeting. He asked that Mike Calimano provide the Committee Members with a report on the progress made with establishing 30-minute transactions instead of transactions occurring once an hour.

Mr. Scheiderich reminded Mr. King that Fred Theadore committed to providing BIC with a summary on the deliverables and costs associated with the Data Warehouse project. Mr. King and Mr. Stalter replied that Mr. Theadore plans to focus on it during the February Project Prioritization Team (PPT) meeting and Mr. Theadore is committed to providing an update at the next MSWG meeting as well.

Mr. Scheiderich pointed out that the Market Participants' view of Interregional Dispatch has been incorrectly conveyed. Mr. King suggested that the NYISO prepare a presentation to deliver to PJM on Interregional Dispatch/Economy Interchange, characterizing New York's view of the topic.

Also, Mr. Bill Heinrich, of the New York State Department of Public Service wondered what the latest developments are concerning the Rate Pancaking/Seams appeals. Mr. King suggested that a PJM representative might be better informed to present an update to the BIC members.

#### VII. Project Priority Team Report

Mr. King informed BIC members that the NYISO completed two projects in December: automation of Real-Time Mitigation and employment of GT Reserves. He also noted that the OSS implementation date has been rescheduled from February to March, due to Oracle problems.

Ms. Saia asked what the NYISO's plans are for correcting problems associated with the proposal for multiple proxies at the seams. Mr. King noted that the NYISO plans to develop a straw proposal that is not prone to gaming. He mentioned that Market Participant advice is encouraged on this issue and should be directed to the Market Structure Working Group (MSWG).

#### VIII. BAWG Issues Update

Mr. Yeomans, on behalf of the Billing and Accounting Working Group (BAWG), updated the BIC Members with a billing project status report.

Mr. Bob Loughney, of Couch White, voiced his concern that project A636, 85/15 RS 1 Split, received FERC's approval in September of 2002 and the BIC members haven't received a report on the status yet. Ms. Elaine Robinson, of the NYISO, replied that Ray Stalter and Dave Lawrence are in the process of constructing a committee issues tracking system that will be posted on the web for this and other projects.

Mr. Scheiderich asked for an update to be provided on the Metering Inventory system. Mr. Stalter replied that the Metering Task Force plans to address this at their next meeting. Mr. Mario Di Valentino, of Strategic Power Management, asked that BAWG inform BIC of LECG's future analysis plans. Mr. Di Valentino specifically wants to know how much longer LECG plans to focus on Rate Schedule 1 and whether they will be looking at other items such as TCC shortfalls.

Mr. Ray Kinney reminded the NYISO that it committed to present its views on the issues associated with Day Ahead Market Contract Balancing. Mr. Yeomans agreed to have NYISO representative, Randy Bowers report to BIC on this issue.

#### IX. Proposal to Sell ICAP Based upon Summer DMNC Ratings

Mr. James D'Andrea, of Keyspan Energy Services, presented an ICAP-related proposal for BIC's consideration. The proposal was presented as a change to the current market design that would enhance reliability as well as improve market efficiencies. In addition, the proposal was noted as being compatible with the demand curve and not intended as an alternative.

Mr. Scheiderich pointed out that the issues that Mr. D'Andrea is proposing had been discussed the previous day in the ICAP Working Group. However, he noted that some BIC members could need additional time to consider these proposals as a package.

Mr. Howard Fromer, of the PSEG, advised that the best action would be to table this motion. He offered background on why BIC originally deferred action on this item: the administrative process for the demand curve process is still being discussed and many details need to be worked out in the Working Groups.

Mr. D'Andrea noted that his main concern is to act on this issue now so that it is resolved in time for next winter.

Mr. Mark Younger, of Slater Consulting, thought the proposal was to vote only on the idea of whether or not to implement the Summer DMNC year round. He noted his concern is that the proposal now contains four other aspects that haven't been discussed.

Several other BIC members including Mike Cadwalader and Ray Kinney expressed their desire for additional time to review the entire proposal. Because of the various concerns with the proposal, Mr. D'Andrea decided not to make the motion. Ms. Laurie King-Pirchner requested that a timeline be established as to when the proposal will return to the BIC members. Mr. Yeomans decided to send the proposal back to the ICAP WG and requested that they provide BIC with a future report. Mr. Kinney wondered if the ICAP WG chair would be interested in addressing Key Span's proposal earlier than at their next scheduled meeting; Mr. Fromer replied that it would be difficult to reschedule the meeting at this point.

#### X. Working Group Updates

- **A.** BAWG Update provide by Mr. Yeomans earlier.
- **B.** Market Structure Working Group (Chair J. Scheiderich) Mr. Scheiderich summarized the MSWG's recent activities. He noted the following: NYSERDA presented on "green" power, the document on the Cross Sound Cable is out for review, a TCC Manual may soon be ready for review, Scott Harvey and Bob Thompson gave a presentation on Economy

Interchange, and Rick Gonzales presented proposed modeling changes to the internal Phase Angle Regulators.

- **C.** Scheduling and Pricing Working Group (Chair R. Kinney) Mr. Kinney informed the BIC members that the S&P WG's next meeting would be on January 28th. He noted a that items on their agenda will include: drafting of the tariff language for the Scarcity Pricing proposal, credit issues, and operating issues. He also mentioned that the S&P WG plans to coordinate with the Credit Policy Task Force.
- **D.** Price Responsive Load Working Group (Chair B. Loughney) Mr. Loughney stated that he did not have any new activities to report.

#### XI. New Business

Mr. Scheiderich mentioned how he would like to see a combined Operational Agreements document available for the Market Participants since the information within it impacts market outcomes. He is considering making a motion in the future to grant access to this information.

#### XII. Administrative Matters

Mr. Ray Stalter, of the NYISO, pointed out the Action Items List is posted and reminded the Committee members to contact him with any questions.

#### XIII. Adjournment

Mr. Dewitt adjourned the meeting at approximately 1:17 P.M.
