

NYISO Transmission Reliability Margin (TRM) and Capacity Benefit Margin (CBM) Used in Determining Available Transfer Capability

The following table of Interface Margins is used in the NYISO Real-Time and Day-Ahead Markets. These margins apply to the hourly periods evaluated for the current day and the next day. In addition, the TRMs included in the following table shall be the same for the six days following the current day and for each of the next twelve months (note that only pre-scheduled transactions across external interfaces may be scheduled further in the future than one day ahead.) These margins shall be the same for both firm and non-firm ATC calculations. These margins shall be in effect starting on March 24, 2011 and shall remain in effect until revised by the NYISO.

These margins shall be the same for both firm and non-firm ATC calculations. These margins shall be in effect starting on March 24, 2011 and shall remain in effect until revised by the NYISO.
