# Activation Requirements

- ◆ SCRs are required to perform at the top of the hour after the NYISO has provided the following notices:
  - *Day-ahead notice at least 21 hours in advance if before 3:00 PM, or at least 24 hours in advance if after 3:00 PM, and*
  - *In-day notice at least two hours in advance*

# Activation Notices

- ◆ In-day email notification of activations will identify if, and for what hours, participation is mandatory
  - *For immediate activations that had a day-ahead notice provided, participation becomes mandatory at the top of the hour after two hours have passed*
- ◆ Example wording for an immediate activation email notice is provided on the following page

# **Example Immediate Activation Email Notice**

**Special Case Resources that can respond immediately are needed today starting at 12:00 and ending at 17:00. Zones included in this notice are: (A-K). Please respond within one hour by logging into the NYISO Demand Response Information System (DRIS) and entering the kW level change expected in each zone. This data is used for reliability and pricing purposes.**

**Mandatory hours for this event, if any, are specified below. Participation in this event is mandatory for each Special Case Resource sold during June 2013 and load reduction achieved by each Special Case Resource during this event is expected to be at the value of the kW's sold. Special Case Resources that fail to participate in the mandatory hours of this event at the value of the kW's sold during June 2013 will be subject to future de-rating, as described in the applicable ISO Procedures and the corresponding RIPS may be subject to deficiency penalties pursuant to ISO Procedures.**

**This constitutes an official Special Case Resource Event Immediate Activation notice.**

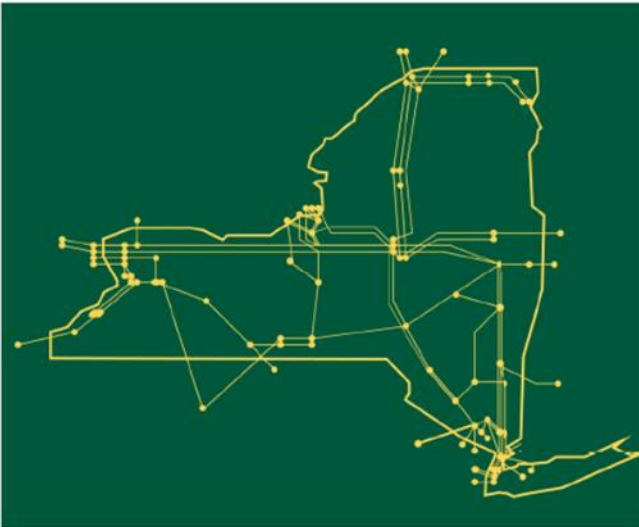

# Performance Requirements

- ◆ Performance for each SCR must be reported for all mandatory hours of SCR events and all hours during tests
- ◆ Performance factors are based on:
  - *The best set of four consecutive mandatory hours in each event that has four or more mandatory hours*
  - *All mandatory hours in each event that has less than four mandatory hours*
  - *All test data*
