 - Make import file format corrections as necessary
- Go to Dashboard to review Enrollment Requests
 - View Pending Enrollment Requests
 - Cancel an Enrollment Request
 - Identify Duplicate Enrollment Requests
 - View Approved or Denied Enrollment Requests

Canceling an Enrollment Request

- Purpose: To cancel a pending request (for example, due to typos or other errors made to a resource record)
 - A resource record can only have one Pending Enrollment Request status at a time
 - In order to re-import a correction to a resource with a Pending Enrollment Request status, the existing Pending Enrollment Request must be canceled
- While displaying the pending resource record in Enrollment Requests Details, click the "Cancel" button in the lower right corner of the screen
