# **DRIS Training**

- Scope will be limited to new functionality specific to each deployment

### NYISO Digital Certificate required for Market Trials

- If you already have a NYISO Digital Certificate, you do not need to request any special privileges for DRIS Market Trials
- NYISO website link:

- Add "DRIS Market Trials to comments" of request
- Recommend request at least 1-2 weeks in advance of Market Trials
  - For first-time requestors, requires authorization from Market Participant's designated Main Contact or MIS Administrator
  - Digital certificate renewals are processed faster
- Confirmation from NYISO is sent to each requestor
  - Digital Certificates are user-specific



### **Market Trials**

- Scheduled for May 25<sup>th</sup> through May 27<sup>th</sup>
  - Access will be from 9am to 3pm each day
  - MIS privileges for Market Trials do not affect MIS privileges after deployment
    - If you will be using DRIS after deployment you should still contact your MIS administrator to be set up with DRIS privileges
- Contact Customer Relations (518-356-6060) with all questions or issues related to DRIS Market Trials
  - Allows NYISO to log all DRIS Market Trial related questions and issues



### **Market Trials continued**

- Registration for Market Trials is required
  - Send e-mail to Mary Beth Imbarrato at: <u>mimbarrato@nyiso.com</u> and include:
    - Organization name
    - Name, phone and e-mail of each participant
    - Whether the participant has a digital certificate or the date on which it was applied for
  - Market Trials guideline document will be sent
    - Includes suggested functions for Market Participants to perform in DRIS

Changed to June 11	NYISO provides RIPs with UCAP reports if updated based on exception corrections
June 21 - no change	Deadline for RIPs to enter UCAP rating (DMNC in ICAP system for July 2010
