Minutes of Meeting

1. Introduction and Meeting Objectives

Mr. Lou Rana, Chairman of the Management Committee (MC), called the meeting to order and welcomed the members of the Management Committee (MC).

Mr. Rana noted that this special meeting of the Management Committee was convened to consider the work of the Bid Cap working group and address any recommendations that may have been developed by the working group. Mr. Rana indicated that these and other recommendations that address pricing issues during the upcoming summer period would be reviewed and discussed in the morning session and that voting on specific proposals would occur following the sector caucus.

2. <u>Report of Bid Cap Task Force</u>

Mr. Harvey Reed, Co-Chairman of the MC and Chairman of the ad hoc Bid Cap Working Group, reported that since the working group was given its charge at the May 24th MC meeting, the group has convened twice with one meeting held in Albany, NY and the second via tele-conference. Mr. Reed added that even though the discussions have been productive relative to clarifying issues, the working group was unable to reach a consensus position.

3. <u>PSC Bid Cap Proposal</u>

Mr. Tariq Niazi of the NYS Consumers Protection Board reviewed several language changes to the Bid Cap proposal. In addition, Mr. Niazi addressed several clarifying questions from MC members. Mr. Ira Freilicher of Hunton & Williams noted that the June 9th filing date may not be feasible due to the need of the NYISO Board to review and discuss several of the modifications included in the current proposal. Mr. Freilicher noted that the Board's next meeting is on June 20th, though if deemed warranted by the Board, they could schedule a special meeting to consider any consensus proposal that might be endorsed by the MC.

Following the discussion, copies of the revised proposal were distributed to the MC members for consideration during their caucus.

4. <u>Other Proposals, as presented by members of the Management Committee</u>

Mr. Rana inquired regarding whether any other MC members wished to offer a proposal for consideration at this time. No addition proposals were brought to the floor in response to Mr. Rana's inquiry.

5. <u>Sector Caucuses</u>

The MC adjourned for caucus at 10:25 AM. By special request, at 11:30 the MC extended the caucus to 1:30 PM to allow additional time for the MC members to consider the modified PSC proposal.

6. <u>Voting</u>

A motion to adopt the Bid Cap Proposal, as modified, was made by Mr. Niazi and seconded by Mr. Len Singer of Couch-White. Following a roll-call vote, the subject motion passed with a vote of 63.15%.

7. <u>Adjournment</u>

A motion was made to adjourn the meeting. The motion was seconded and approved with the meeting adjourned at 2pm.
