I. Approval of Board Meeting Minutes

Upon motion duly made and seconded, the Board approved the January 12, 2021 Board meeting minutes, and deferred approval of the February 9, 2021 Board meeting minutes until the next meeting.

II. Consent Agenda

Mr. Gonzales briefed the Board on the items outlined in his COO Report, included in the Board package, and reported on the NYISO Grid Operations coordination with the DOE's Argonne National Laboratory and the New York Transmission Owners staffs regarding coordination of load shed plans and electric driven natural gas compressor stations. Argonne National Laboratory staff has developed extensive data and modeling capabilities in the electric-gas coordination space and established working relationships with the MISO, TVA, PJM, ISO-NE, and the NYISO. All electric driven gas natural compressor stations were removed from the two utilities' load shed plans as of August 19, 2020.
