

Extension of Time to Provide Notice and Consent for Developers of Viable and Sufficient Solutions to the Long Island Offshore Wind Export Public Policy Transmission Need

April 14, 2022

Dear NYISO Developers and Market Participants:

On April 5, 2022, the New York Independent System Operator (“NYISO”) filed at the New York State Public Service Commission (“NYPSC”) the Long Island Offshore Wind Export Public Policy Transmission Need (“Long Island Offshore Wind Export PPTN”) Viability & Sufficiency Assessment in NYPSC Case No. 20-E-0497.¹ Under Section 31.4.6.6 of the Open Access Transmission Tariff (“OATT”), Developers of proposed solutions that the NYISO identified as viable and sufficient shall:

Within 15 Calendar Days following the ISO’s filing of the Viability and Sufficiency Assessment at the NYPSC, which time period may be extended by the ISO pursuant to Section 31.1.8.7, all Developers of proposed Public Policy Transmission Projects that the ISO has determined satisfy the viability and sufficiency requirements in this Section 31.4.6 shall notify the ISO whether they intend for their projects to proceed to be evaluated by the ISO for purposes of the ISO’s selection of the more efficient or cost effective Public Policy Transmission Project to satisfy an identified Public Policy Transmission Need.

Pursuant to Section 31.1.8.7 of the OATT, the NYISO hereby notifies Developers and Market Participants that the aforementioned deadline of April 20, 2022 will be extended for all Developers of proposed solutions that the NYISO identified as viable and sufficient to meet the Long Island Offshore Wind Export PPTN until **May 9, 2022**. Developer Election to Proceed
Long Island Offshore Wind Export Public Policy Transmission Need
Form due May 9, 2022

_____ (“Developer”) has submitted a Public Policy Transmission Project known as _____ (“Transmission Project”) in response to the NYISO’s August 12, 2021 solicitation for solutions to address the Long Island Offshore Wind Export Public Policy Transmission Need (“Transmission Need”) in its Public Policy Transmission Planning Process. On April 5, 2022, the NYISO submitted to the New York State Public Service Commission its Long Island Offshore Wind Export Public Policy Transmission Need Viability and Sufficiency Assessment, which identified the Transmission Project as a viable and sufficient solution.

Pursuant to Section 31.4.6.6 of the NYISO’s Open Access Transmission Tariff (“OATT”), Developer is required to submit to the NYISO this Election to Proceed no later than May 9, 2022 for its Transmission Project to be evaluated for purposes of the NYISO’s selection of the more efficient or cost-effective Public Policy Transmission Project to address the Transmission Need.

Developer submits this form to notify the NYISO that it: [check each]

_____ Elects for its Transmission Project to proceed to be evaluated by the NYISO for purposes of the NYISO’s selection of the more efficient or cost-effective Public Policy Transmission Project to address the Transmission Need; and

_____ Certifies that it has executed a System Impact Study (“SIS”) or System Reliability Impact Study (“SRIS”) Agreement for its Transmission Project, as applicable.

The completed form, executed by a duly authorized officer or agent of the Developer, must be sent electronically to: publicpolicyplanningmailbox@nyiso.com with a subject line, “LI PPTN Election to Proceed.” Developer understands and acknowledges that if it fails to submit this form by May 9, 2022 or fails to check one of the above items, the NYISO will remove the Transmission Project from further consideration in the current planning cycle.
