## **Semi-Annual Demand Response Report**

#### The NYISO proposes to

- Post on its website, a single annual report containing all information currently included in the annual (January) report to FERC
- Discontinue the obligation to file with FERC the annual report and to file and prepare the semi-annual (June) report
- The June report duplicates significant information in the January report
- Most of this information is relatively static from report to report. For instance, the four DSM
  programs have evolved, and are updated by the NYISO from time-to-time, but any changes to
  those programs tend to be fairly incremental
- It would be more efficient to annually post the information on DSM now contained in the annual DSM rather than filing a reports
