August 2015 Operations Performance Highlights

- Peak load of 30,543 MW occurred on 8/17/2015 HB 16
- All-time summer capability period peak load of 33,956 MW occurred on 7/19/2013 HB 16
- 6.6 hours of Thunder Storm Alerts were declared
- 0 hours of NERC TLR level 3 curtailment
- A Major Emergency was declared on 8/21/2015 when the Rock Tavern-Coopers 345kV (#42) and Coopers-Middletown-Rock Tavern 345kV (#34) circuits (common tower) tripped causing the Central East interface flow to exceed its voltage collapse limit.
- The following table identifies the estimated production cost savings associated with the Broader Regional Market initiatives.

Description

Represents the value NY realizes from Market-to-Market Ramapo Coordination. When experiencing congestion, this includes (1) the estimated savings to NY for additional deliveries into NY, plus (2) PJM compensation to NY for additional deliveries into PJM (as compared to the Ramapo Target level, excluding RECO). This is net of any settlements to PJM when they are congested.

Represents the value of PJM's obligation to deliver 80% of service to RECO load over Ramapo 5018. This includes (1) the estimated reduction in NYCA congestion due to the PJM delivery of RECO over Ramapo 5018, plus (2) PJM compensation to NY for NYCA congestion for the under-delivery or inability to deliver service to RECO load over Ramapo 5018.








<u>Description</u> NYISO savings that result from PJM payments to NYISO when PJM's transmission use (PJM's market flow) is greater than PJM's entitlement of the NY transmission system and NYISO is incurring Western or Central NY congestion. Additionally, NYISO savings may result from the more efficient regional utilization of PJM's generation resources to directly address Western or Central NY transmission congestion.











































Market Performance Highlights for August 2015

- LBMP for August is \$33.09/MWh; lower than \$34.78/MWh in July 2015 and lower than \$34.48/MWh in August 2014.
 - Day Ahead Load Weighted LBMPs are lower compared to July.
 - Real Time Load Weighted LBMPs are higher compared to July.
 - > This is the lowest LBMP for the month of August during NYISO operation.
- August 2015 average year-to-date monthly cost of \$50.22/MWh is a 39% decrease from \$82.60/MWh in August 2014.
- Average daily sendout is 511 GWh/day in August; lower than 512 GWh/day in June 2015 and higher than 470 GWh/day in August 2014.
- Natural gas prices were higher compared to the previous month and distillate prices were lower compared to the previous month.
 - Natural Gas (Transco Z6 NY) was \$2.38/MMBtu, up 20% from \$1.99/MMBtu in July.
 - Jet Kerosene Gulf Coast was \$10.34/MMBtu, down from \$11.51/MMBtu in July.
 - Ultra Low Sulfur No.2 Diesel NY Harbor was \$10.86/MMBtu, down from \$12.07/MMBtu in July.
 - Distillate prices are down 49% year-over-year
- Uplift per MWh is lower compared to the previous month.
 - Uplift (not including NYISO cost of operations) is \$0.03/MWh; lower than \$0.04/MWh in July.
 - The Local Reliability Share is \$0.36/MWh, higher than \$0.34 in July.
 - The Statewide Share is (\$0.33)/MWh, lower than (\$0.31)/MWh in July.
 - TSA \$ per NYC MWh is \$0.06/MWh.
 - Total uplift costs (Schedule 1 components including NYISO Cost of Operations) are slightly lower than July.



DAM Contract Balancing amounts are for payments made to generating units to make them whole for being dispatched below their Day-Ahead schedule, as a result of out-of-merit dispatches. DAM Bid Production Cost Guarantees for Virtual Transactions are included in the chart and are shown from the inception of Virtual Transactions. These values are small and cannot be identified on the chart. DAM residuals consist of both energy and loss revenue collections and payments. By design, there is a net over collection of revenues due to the difference between the marginal losses paid to generation and the average losses charged to loads.
