THE NEW YORK INDEPENDENT SYSTEM OPERATOR, INC. FINAL MINUTES OF BOARD OF DIRECTOR'S MEETING REGULAR SESSION – MARCH 15, 2022

The Board of Directors of the New York Independent System Operator (NYISO) met at Hunton Andrews Kurth offices in NYC on March 15, 2022. Chairman Dan Hill chaired the meeting, and all Board members were present. Ms. Egan, Ms. Nelson, and Messrs. Fernandez, Gonzales, Jones, and Lanahan, were also present. Ms. Hussey and Mr. Mukerji participated via teleconference. Mr. Adam Evans of the Public Service Commission also participated via teleconference.

I. Approval of Board Meeting Minutes

Upon motion duly made and seconded, the Board approved the December 2, 2021 Board meeting minutes, and deferred approval of the February 15, 2022 Board meeting minutes until the next meeting.

II. Consent Agenda

There were no items on the Consent Agenda this month.

III. Report of the Board Chair

Chairman Dan Hill reported that the April Board meetings will be held at NYISO headquarters in Rensselaer, and we will also schedule an event with the market participants on April 11th at the Desmond.

IV. Committee Reports

A. Audit & Compliance

Ms. Marrinan reported that the Audit & Compliance Committee met on March 14, 2022 and discussed, and approved the following:

- 1. February 14, 2022 A&C Committee meeting minutes approved.
- 2. Audit & Compliance Committee Charter The Committee reviewed and approved the Charter, as presented. The Charter will be presented to the Governance Committee for approval in April.
- 3. Cyber & Physical Security Update Mr. Chapman provided a thorough Cyber & Physical Security Program Update, including the following:
 - An update on a major zero-day vulnerability in a commonly used software library called Log4J.

- NERC Critical Infrastructure Protection (CIP) Audit On February 8, 2022, NPCC sent a final draft report confirming there were no findings or potential violations, no areas of concern, and five recommendations on how the NYISO can strengthen its compliance program. The NYISO IT teams have begun developing plans to evaluate and implement NPCC's recommendations.
- Microsoft 365 information protection capabilities the NYISO is employing advanced technical controls that will, over time, help prevent the disclosure of sensitive documents to unintended recipients.
- An update on the actions the NYISO security team has taken in response to the Geopolitical Tensions in Eastern Europe.

B. Commerce & Compensation

Mr. David Hill reported that the Commerce & Compensation Committee met on March 14, 2022 and discussed the following:

- 1. 2021 Customer Satisfaction Survey Results The Customer Inquiry satisfaction score was 98.3%, a decrease of .3% over last year. The overall satisfaction score for the Market Participant surveys was 91.1%, a decrease of .4% over last year, and the overall satisfaction score for the Executive Strategic Outreach survey was 77.0%, a decrease of .6% over last year.
- 2. Workforce update.

C. Governance

- 4. Load Forecasting Processes Short & Long Term.
