

NYISO is conducting training designed to better prepare you for your participation in the Sandbox Testing sessions associated with the <u>Coordinated Transaction Scheduling (CTS)</u> with ISO-NE project (to be deployed in the fourth quarter of 2015) as it was discussed during the February 12 and March 10, 2015 Market Issues Working Group meetings.

As noted below, the training session will cover multiple functional changes to be tested during these pre-deployment Sandbox sessions. The training material assumes that attendees have a basic familiarity with NYISO and ISO-NE Market Rules on Transactions. The NYISO training will be offered via WebEx on multiple occasions prior to Sandbox Testing. The webinar is expected to be approximately 2.5 hours in duration.

The training will primarily focus on content for participants who are New York customers, with additional information provided by ISO New England for participants that are both New York and New England customers. New England-only customers are also welcome to register. However, ISO-NE will provide full CTS training on JESS, EES, settlements, and report changes in September and October. Details and registration information on these upcoming sessions will be sent from ISO New England Customer Training.

For NYISO Market Participants and Market Participants who are also ISO-NE customers: Please note that the July and August sessions will be concentrating on the changes NYISO Market Participants can expect at the interface with ISO-NE, with a section on minimum actions required to participate by an ISO-NE MP.

FOR ISO-NE Market Participants: The September and October full CTS training sessions will include changes the ISO-NE Market Participant can expect in JESS, which will largely replace the ISO-NE EES for transactions at the Roseton/Sandy Pond interface.
