Project Description:

 Engaging the Demand Side is intended to be a highly collaborative project that will leverage stakeholder feedback in identifying potential issues with or gaps in the NYISO's existing participation opportunities for Demand Side Resources and DER generators. Information gathered as part of this project will inform a final report to be released in Q4 of 2023, which will recommend next steps regarding future Market Design projects/efforts to address solicited feedback.

Demand Side Resource and DER Generator Participation

- NYISO has heard feedback that the present SCR and DER models will still make it difficult for participation of some Demand Side Resources and/or DER generators
- NYISO would like to hear more specific Stakeholder feedback regarding:
 - Operational (or other) issues/risks that participants face in the NYISO's demand response and DER models, and
 - How those issues/risks change how participants participate in the NYISO-administered wholesale markets



Small DER Participation

- NYISO seeks to gather feedback from the March 22/23 discussions regarding Small DER Participation:
 - NYISO would like to gather additional detailed feedback regarding potential use cases for small DER.
