I. Approval of Board Meeting Minutes

Upon motion duly made and seconded, the Board approved the November 15, 2022 Board meeting minutes, and deferred approval of the December 1, 2022 Board meeting minutes until the next meeting.

II. Consent Agenda

There were no items on the Consent Agenda this month.

III. Report of the Board Chair

Chairman Dan Hill provided his report in Executive Session.

IV. Committee Reports

A. Audit & Compliance

Mr. David Hill reported that the Audit & Compliance Committee did not meet this month.

B. Commerce & Compensation

Mr. Gizman Abbas reported that the Commerce & Compensation Committee (C&C) met on January 9, 2023 and approved the revised 2023 CEO Goals. Mr. Abbas made a motion for Board approval of the revised 2023 CEO Goals, which was approved by the Board.

D. Reliability & Markets

Tariff Revision NYTOs Initiative to Align Funding Mechanisms for Network Upgrade Facilities and Selected Public Policy Transmission Project Mr. Oates made a motion for Board approval of the proposed tariff revisions, and to authorize NYISO management to file these revisions with the Federal Energy Regulatory Commission, pursuant to Section 205 of the Federal Power Act, which was approved by the Board.
- 3. Long Island PPTN Update.
- 4. Briefing on recent grid challenges experienced over the December 23-26, 2022 cold weather period.
