Dear Secretary Bose:

Central Hudson Gas and Electric Corporation (“Central Hudson”) hereby submits for informational purposes its projected Hurley-FC annual transmission revenue requirement (“ATRR”) for the period June 2023 to May 2024 in accordance with Description of Annual Update Process (“Protocols”) set forth in the NYISO Open Access Transmission Tariff (“OATT”), Section 6.12.5.2.2. This is filed with the Federal Energy Regulatory Commission (“Commission”) in accordance with the Protocols, which requires Central Hudson to calculate and request the NYISO to post to its website annually the Hurley-FC ATRR on or before April 15th and further provides that an Informational Filing be filed by May 15th with the Commission, including reflecting any changes in response to comments submitted by interested parties. The Informational Filing does not require any Commission action. No interested party had submitted comments by the May 1, 2023 deadline.

This Informational filing includes three attachments.

Attachment A is an Excel spreadsheet that summarizes the ATRR computations. The projected ATRR for June 2023 through May 2024 is \$2,346,279. This is the first ATRR for the Hurley Project, which entered plant in service (FERC Accounts 101 or 106) in May 2023.
