

## **Status of Class Year 2023 and Expedited Deliverability Study 2023-01**

- **Class Year 2023 (CY23)**
  - CY23 officially started on February 13, 2023.
    - The NYISO received over 100 notices of intent to join CY23.
    - After reviewing the eligibility of each request, NYISO tendered FSAs to all eligible CY23 members in mid-February, triggering the requirement that Developers submit completed FSA forms, required data and deposits.
    - The NYISO has finished validating all 84 projects' FSA data in CY23. All CY23 projects' FSA were fully executed by end of April.
    - CY23 participant list was released on May 5, 2023.
    - CY23 overview and work plan was presented at IPFSWG on May 25, 2023.
    - CY23 ATBA Base Case
      - , Anotice of completion of CY23 ATBA was sent to stakeholders on June 6, one week before the completion date. The ATBA series of cases was completed on June 13, 2023.
      - Only local transmission upgrades that satisfied the ATBA inclusion rules, including designation as "firm" by the applicable Transmission Owner, are included in the ATBA; however, to the extent SUFs or SDUs are required that can be mitigated by local transmission upgrades, they will be evaluated as potential solutions to mitigate the need for SUFs or SDUs.
- **Expedited Deliverability Studies (EDS)**
  - The EDS study (EDS 2023-01) started on February 24, 2023.
    - The NYISO received over 15 requests to join EDS 2023-1.
    - After reviewing the eligibility of each request, NYISO tendered EDS agreements to developers in March.
    - All EDS agreements were fully executed by end of May.
