Background

- NYC PPTN developers proposing a project are required to complete, compile, and submit a specific set of documents to be considered, including:
 - Proposed solutions are required to include all project information to NYISO as described in Sections 31.4.4.3, 31.4.4.4, and 31.4.5 of Attachment Y
 - Proposed Public Policy Transmission Projects must submit the information required in Section 31.4.5.1 of Attachment Y by completing and submitting to NYISO the forms set forth in Attachments B and C to the PPTPP Manual
 - Other Public Policy Projects must submit the information required in Section 31.4.5.1 of Attachment Y by completing and submitting to NYISO the forms set forth in Attachment B to the PPTPP Manual
 - In addition to the information contained in Attachments B and C, Developers must submit information specific to the Public Policy Transmission Need as requested by NYISO



Summary of Requested Information

- The tariff requires Developers of proposed projects to submit information requested by NYISO specific to the Public Policy Transmission Need, and such information should be submitted in Attachment B to the PPTPP Manual
- For NYC PPTN, NYISO will request Developers to provide information as outlined in the "New York City PPTN Information Request" document
 - This information is in response to question 13 of Attachment B to the PPTPP Manual
 - Append the filled-in document to Attachment B



Summary of Requested Information (contd)

- The information request document will require the following data:
 - Summary of proposed facilities
 - Facility characterization (new, Public Policy Transmission Upgrade, preliminary identification of potential interconnection facilities)
 - Project modeling data (proposed facilities and generator model)
 - Project related contingencies
 - System Adjustments to accommodate proposed offshore wind under applicable reliability standards



Summary of Requested Information (contd)

- Data provided in the information request document must be consistent with the data submitted in Attachments B and C to the PPTPP Manual
- Developers will need to provide the information in the specific requested format similar to version posted with today's presentation
- Developers will be provided access to the final version concurrently with the posting of the solicitation letter



Attachments B and C Updates

- The NYISO presented proposed changes to Attachments B and C at the December 19, 2023 ESPWG
- The draft proposed changes can be accessed in the <u>December 19th meeting material</u>
- Final version will be made available before opening of the solicitation window



A potential NYC PPTN solution was evaluated using information provided by NYISO. Following transmission constraints require additional transmission system data to finalize a proposal.




