### **Evolving Financial Transaction Capabilities**

- Evolving Financial Transaction Capabilities project will enhance internal bilateral transaction functionality by increasing the range of internal bilateral contracting opportunities (i.e., sink locations) by creating the opportunity for internal bilateral contracts in which Withdrawal-Eligible Generators can be the sink
- Withdrawal-Eligible Generator ("WEG") MST Definition:
  - A Generator that is eligible to withdraw energy from the grid at a price for the purposes of recharging or refilling for later injection back into the grid.



### Transaction Contract Schedules Class Structure





#### Load Bus Class Structure




